- (D) "CHIEF EXECUTIVE OFFICER" MEANS THE PRESIDENT, CHAIRMAN, MAYOR, COUNTY EXECUTIVE, OR OTHER CHIEF EXECUTIVE OFFICER OF A LOCAL GOVERNING BODY, IF ANY, HOWEVER DESIGNATED, WHETHER ELECTED TO THE OFFICE OR ACTING AS SUCH UNDER LAW.
- (E) "COMMISSIONER COUNTY" MEANS ANY COUNTY OF MARYLAND, OTHER THAN A COUNTY SUBJECT TO THE PROVISIONS OF ARTICLE 25A OR ARTICLE 25B OF THE ANNOTATED CODE OF MARYLAND.
- (F) "DESIGNATED BLIGHTED AREA" MEANS AN AREA DESIGNATED BY A LOCAL GOVERNING BODY BY ORDINANCE OR ADMINISTRATIVE RESOLUTION IN ACCORDANCE WITH § 14-805(A) OF THIS SUBTITLE.
- (G) "FINANCED AREA" MEANS, WITH RESPECT TO AN ISSUE OF BONDS, THE PORTION OF THE AFFECTED DESIGNATED BLIGHTED AREA WITH RESPECT TO WHICH THE PROCEEDS OF SUCH ISSUE OF BONDS ARE TO BE USED, AS DESIGNATED BY A LOCAL GOVERNING BODY BY ORDINANCE OR ADMINISTRATIVE RESOLUTION IN ACCORDANCE WITH § $\frac{14-3\theta6}{A}$
- (H) "LOCAL GOVERNING BODY" MEANS ANY OF THE 23 COUNTIES OF MARYLAND, A MUNICIPALITY, OR THE MAYOR AND CITY COUNCIL OF BALTIMORE.
- (I) "MUNICIPALITY" MEANS A MUNICIPAL CORPORATION SUBJECT TO THE PROVISIONS OF ARTICLE XI-E OF THE CONSTITUTION.
- (J) "REDEVELOPMENT PURPOSES" MEANS, WITH RESPECT TO ANY DESIGNATED BLIGHTED AREA:
- (1) ACQUISITION BY THE LOCAL GOVERNING BODY OF REAL PROPERTY LOCATED IN SUCH AREA;
- (2) CLEARING AND PREPARATION FOR REDEVELOPMENT OF LAND IN SUCH AREA WHICH WAS ACQUIRED BY THE LOCAL GOVERNING BODY;
- (3) REHABILITATION OF REAL PROPERTY LOCATED IN SUCH AREA WHICH WAS ACQUIRED BY THE LOCAL GOVERNING BODY; AND
- (4) THE RELOCATION OF OCCUPANTS OF SUCH REAL PROPERTY.
- (K) "ORDINANCE OR RESOLUTION" MEANS AN ENACTMENT ADOPTED BY A LOCAL GOVERNING BODY PURSUANT TO PROCEDURES SPECIFIED BY APPLICABLE LOCAL CHARTER OR PUBLIC LOCAL LAWS.
