- (b) The insurance policy shall be procured from any insurer or surety that is acceptable to the Insurance Commissioner of Maryland.
- (c) A certificate of insurance shall be furnished to the Commissioner prior to the issuance of a certificate of inspection.
- (D) (1) AN AMUSEMENT RIDE OR ATTRACTION, OWNED AND OPERATED BY A NONPROFIT COMMUNITY SERVICE CORPORATION INCORPORATED UNDER MARYLAND LAW THAT IS AUTHORIZED TO COLLECT CHARGES OR ASSESSMENTS BY A COVENANT RUNNING WITH THE LAND AND THAT HAS GROSS ANNUAL REVENUES OF AT LEAST \$15,000,000, COMPLIES WITH THIS SECTION IF IT IS SELF-INSURED FOR AT LEAST \$1,000,000 AGAINST LIABILITY FOR INJURY ARISING OUT OF THE USE OF THE AMUSEMENT RIDE OR ATTRACTION UNDER THE RUBES-AND REGULATIONS ADOPTED BY THE STATE INSURANCE COMMISSIONER.
- (2) THE OWNER OR LESSEE OF AN AMUSEMENT RIDE OR ATTRACTION THAT ELECTS TO SELF-INSURE UNDER THIS SUBSECTION PERIODICALLY SHALL FILE WITH THE STATE INSURANCE COMMISSIONER, IN WRITING, THE TERMS AND CONDITIONS OF THE SELF-INSURANCE.
