A COUNTY THAT MERELY PURCHASES INSURANCE FOR A LESSEE OR OWNER OF AN AMUSEMENT RIDE OR AMUSEMENT ATTRACTION IS IMMUNE FROM LIABILITY FOR PERSONAL INJURY INDIVIDUALS ARISING OUT OF THE USE 0F THE AMUSEMENT RIDE ATTRACTION.

- [(b)] (C) The insurance policy shall be procured from any insurer or surety that is acceptable to the Insurance Commissioner of Maryland.
- [(c)] (D) A certificate of insurance shall be furnished to the Commissioner prior to the issuance of a certificate of inspection.
- (E) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
- (2) "MECHANICAL AMUSEMENT RIDE" MEANS ANY MECHANICAL DEVICE THAT CARRIES OR CONVEYS PASSENGERS ALONG, AROUND, OR OVER A FIXED OR RESTRICTED ROUTE OR COURSE OR WITHIN A DEFINED AREA, FOR THE PURPOSE OF GIVING ITS PASSENGERS AMUSEMENT, PLEASURE, THRILLS, OR EXCITEMENT.
- THAT CARRIES OR CONVEYS PASSENGERS BY THE PASSENGERS' OWN POWER OR BY GRAVITY, INCLUDING BUT NOT LIMITED TO WATER SLIDES AND WATER FLUMES, ALONG, AROUND, OR OVER A FIXED OR RESTRICTED ROUTE OR COURSE OR WITHIN A DEFINED AREA, FOR THE PURPOSE OF GIVING ITS PASSENGERS AMUSEMENT, PLEASURE, THRILLS, OR EXCITEMENT.
