RESOLUTION OF THE MAYOR AND COUNCIL OF FEDERALSBURG TO ADD TO THE CORPORATE BOUNDARIES OF SAID MUNICIPAL CORPORATION, SUBJECT TO THE PROVISIONS OF THE CHARTER OF SAID MUNICIPAL CORPORATION, TWENTY-FIVE PER CENTUM (25%) OF THE PERSONS WHO RESIDE IN THE AREA TO BE ANNEXED AND WHO ARE REGISTERED AS VOTERS IN COUNTY ELECTIONS AND TWENTY-FIVE PER CENTUM (25%) OF THE OWNERS OF THE ASSESSED VALUATION OF REAL PROPERTY LOCATED IN THE AREA HAVING CONSENTED THERETO, BY REPEALING ORDINANCE NO. 141 OF THE ORDINANCES OF SAID TOWN AS PASSED AND MADE EFFECTIVE ON March 3rd, 1986, ENTITLED "AN ORDINANCE DESIGNATING THE BOUNDARIES OF THE TOWN OF FEDERALSBURG AND REPEALING ALL ORDINANCES INCONSISTENT THERewith": AND ENACTING IN LIEU THEREOF, A NEW ORDINANCE DELINEATING THE CORPORATE LIMITS OF THE SAID TOWN SO THAT THERE SHALL BE INCLUDED WITHIN THE CORPORATE LIMITS OF THE SAID TOWN APPROXIMATELY 143 ACRES LOCATED TO THE NORTHWEST SIDE OF THE PRESENT CORPORATE LIMITS OF SAID TOWN, LYING AND ENCOMPASSING PART OF THE FEDERALSBURG BY-PASS BETWEEN MARYLAND ROUTE 319 AND ACADEMY AVENUE. BEING PROPERTIES AS MORE FULLY SET OUT BY A PLAT DATED 8/11/86 BY J.R. MCCRONE AND BEING DIRECTLY CONTIGUOUS TO THE PRESENT FEDERALSBURG TOWN BOUNDARY LINES.

A RESOLUTION FOR THE ENLARGEMENT OF THE CORPORATE BOUNDARIES OF THE CITY OF FREDERICK BY EXTENDING THE CORPORATE LIMITS OF THE CITY AND IN SO DOING TO REPEAL AND RE-ENACT WITH AMENDMENTS ARTICLE 1, ENTITLED "INCORPORATION AND GENERAL GOVERNMENT", SECTION 2, ENTITLED "BOUNDARIES", OF THE CHARTER OF THE CITY OF FREDERICK: TO PROVIDE FOR THE ANNEXATION OF 251.136 ACRES OF LAND, MORE OR LESS, GENERALLY ALONG THE NORTHERN BOUNDARY OF THE CITY.
