SECTION 23. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that funds appropriated in object classification .03 - Communications, subobject CO2 - Telephone, are to be expended for that purpose only and may not be transferred to another object of expenditure by budget amendment or otherwise.

SECTION 24. AND BE IT FURTHER ENACTED, That the fiscal year 1988 appropriations made in Section 1 to the programs listed below shall be reduced by the amounts indicated for the purpose of curtailing expenditures for communications:
