[(a)-]- Except as provided in subsection (b) of this section, any] ANY motor carrier who violates the provisions of §§ 422 or 423 of this subtitle shall be guilty of a misdemeanor and shall be charged and receive a citation as provided in Title 26 of the Transportation Article and, on conviction, shall be fined not less than \$200 nor more than \$500 for each offense.

[(b) If the specific vehicle of a motor carrier is registered under § 423 of this subtitle but fails to display the valid identification marker required under this subtitle or fails to possess or surrender the registration card required under this subtitle to an officer who demands to inspect the card, the motor carrier shall be charged and receive a citation as provided in Title 26 of the Transportation Article and on conviction may be fined not more than \$25 for each offense.]
