SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 11-101 through 11-202 and the title "Title 11. General Provisions"; 12-101 through 12-303 and the title "Title 12. State Board for Higher Education"; 13-101 through 13-106 and 13-108, and the subtitle "Subtitle 2. Morgan State University"; and 14-101 through 14-301 and the title "Title 14. Board of Trustees of State Universities and Colleges" and the various subtitles; ~~and 18-202, 18-203, 18-205, 18-307, and 18-805~~ and the title "Title 15. St. Mary's College"; of Article - Education of the Annotated Code of Maryland be repealed.
