THE COMMISSION MAY ADOPT REGULATIONS TO CARRY OUT THE PROVISIONS OF THIS SUBTITLE, INCLUDING REGULATIONS THAT ESTABLISH:

- (1) DEADLINES FOR SUBMISSION OF MISSION STATEMENTS, PERFORMANCE ACCOUNTABILITY PLANS, AND ANNUAL REPORTS; AND
- (2) FORMATS AND GUIDELINES FOR THE PREPARATION OF PLANS AND REPORTS.

SUBTITLE 4. OTHER POWERS AND DUTIES

11-401.

- (A) BEFORE ANY INSTITUTION OF POSTSECONDARY EDUCATION OPERATING IN THIS STATE DISCONTINUES OPERATION, ITS ADMINISTRATIVE OFFICER SHALL FILE WITH THE COMMISSION THE ORIGINAL OR LEGIBLE COPIES OF ALL ESSENTIAL RECORDS OF THE ACADEMIC ACHIEVEMENTS OF ALL FORMER STUDENTS OF THE INSTITUTION.
 - (B) THE RECORDS SHALL PRESENT, AS SEPARATE DOCUMENTS:
 - (1) THE ACADEMIC RECORD OF EACH FORMER STUDENT: AND
- (2) ANY OTHER ACADEMIC INFORMATION USUALLY REQUIRED INSTITUTIONS OF POSTSECONDARY EDUCATION WHEN CONSIDERING STUDENTS FOR TRANSFER OR ADVANCED STUDY.
- (C) THE COMMISSION SHALL MAINTAIN A PERMANENT FILE OF ALL RECORDS FILED WITH IT UNDER THIS SECTION.

11-402.

- (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
- (2) (I) "SCHOOL" MEANS A POSTSECONDARY--NONDEGREE GRANTING-PROPRIETARY-INSTITUTION PRIVATE CAREER SCHOOL LOCATED OUTSIDE THE STATE.
- (II) "SCHOOL" DOES NOT INCLUDE A POSTSECONDARY NONDEGREE-GRANTING-PROPRIETARY-INSTITUTION PRIVATE CAREER SCHOOL THAT OPERATES IN THE STATE PURSUANT TO A CERTIFICATE OF APPROVAL ISSUED UNDER § $\pm \pm -3\theta = 11-202(B)$ OF THIS TITLE.
- (3) "SOLICITOR" MEANS A PERSON ENGAGED IN THE BUSINESS, FOR COMPENSATION, OF SOLICITING OR OFFERING TO SOLICIT STUDENTS IN THIS STATE TO ENROLL IN OR APPLY FOR A PROGRAM OFFERED BY A SCHOOL.
- (B) A PERSON MAY NOT ACT AS A SOLICITOR UNLESS SUCH PERSON HAS A PERMIT ISSUED UNDER THIS SECTION.
