{5} -- EXCEPT AS PROVIDED IN PARAGRAPHS {1} AND {6} OF
THIS SUBSECTION, A MUNICIPAL CORPORATION SHALL:

{i} -- 6 -- MONTHS -- PRIOR -- TO -- ITS -- MUNICIPAL -- ELECTION,
PURCHASE PRECINCT LISTS FROM A LOCAL BOARD FOR THOSE PRECINCTS
LOCATED IN WHOLE OR IN PART WITHIN THE BOUNDARIES OF THE
MUNICIPAL CORPORATION; AND

{ii} -- DELETE FROM THE PURCHASED PRECINCT LISTS
THE NAME OF ANY INDIVIDUAL WHO IS NOT A RESIDENT OF THE MUNICIPAL
CORPORATION.

{6} {i} -- A -- MUNICIPAL -- CORPORATION -- MAY -- REQUEST -- THAT -- A
BOARD PROVIDE TO THE MUNICIPAL CORPORATION A CERTIFIED LIST OF
REGISTERED VOTERS THAT:

1. -- INCLUDES ONLY THE NAMES OF INDIVIDUALS
RESIDING WITHIN THE BOUNDARIES OF THE MUNICIPAL CORPORATION;

2. -- PROVIDES ONLY CERTAIN INFORMATION AS
SPECIFIED IN THE REQUEST; OR

3. -- ORGANIZES THE NAMES OR INFORMATION AS
SPECIFIED IN THE REQUEST.

{ii} -- THE REQUEST SHALL BE:

1. -- IN WRITING; AND

2. -- FILED WITH THE APPROPRIATE LOCAL
BOARD.

{iii} -- THE REQUEST SHALL INCLUDE:

1. -- IF NEEDED TO FULFILL THE REQUEST, A
DESCRIPTION OF THE BOUNDARIES, PRECINCTS, WARDS, DISTRICTS, OR
ROLLING PLACES OF THE MUNICIPAL CORPORATION;

2. -- A SPECIFIC LIST OF THE INFORMATION TO
BE INCLUDED OR EXCLUDED ON THE REQUESTED LIST; AND

3. -- THE NAME AND PHONE NUMBER OF THE
MUNICIPAL CORPORATION'S LIAISON TO THE LOCAL BOARD.

{iv} 1. -- THE LOCAL BOARD AND THE MUNICIPAL
CORPORATION SHALL SHARE THE INITIAL COST TO PRODUCE A LIST IN THE
MANNER REQUESTED BY THE MUNICIPAL CORPORATION UNDER SUBPARAGRAPH
{1} OF THIS PARAGRAPH.
