

QUALIFICATION FOR VOTING IN MUNICIPAL ELECTIONS AND CONTINUES TO DO SO; OR

(III) PROVIDES FOR THE BOARD TO CONDUCT MUNICIPAL ELECTIONS AS PROVIDED IN § 2-9(A) OF THIS ARTICLE.

(2) -- REGISTRATION BY THE BOARD OF A VOTER WHO RESIDES IN A MUNICIPAL CORPORATION LOCATED WITHIN THE COUNTY SHALL BE DEEMED REGISTRATION FOR ELECTIONS OF THAT MUNICIPAL CORPORATION.

(3) -- SIX MONTHS PRIOR TO ITS MUNICIPAL ELECTION EACH MUNICIPAL CORPORATION NOT EXEMPTED IN PARAGRAPH (1) OF THIS SUBSECTION SHALL APPLY IN WRITING TO THE BOARD FOR A VOTER REGISTRATION LIST OF THOSE VOTERS WHO RESIDE WITHIN THE MUNICIPAL CORPORATION'S BOUNDARIES.

(4) -- THE APPLICATION SHALL INCLUDE A DESCRIPTION OF MUNICIPAL BOUNDARIES, PRECINCTS, WARDS, OR DISTRICTS.

(5) -- THE APPLICATION SHALL ALSO INCLUDE A STATEMENT INDICATING WHETHER THE MUNICIPAL CORPORATION WANTS THE EXCLUSION OR INCLUSION OF POLITICAL PARTY AFFILIATION ON THE VOTER REGISTRATION LIST AND THE DATE OF BIRTH OF THE VOTER.

(6) -- THE MUNICIPAL CORPORATION SHALL DESIGNATE A MUNICIPAL LIAISON TO THE BOARD WHOSE NAME SHALL BE INCLUDED IN THE APPLICATION.

(7) (i) -- WITHIN 15 DAYS OF RECEIPT OF AN APPLICATION BY THE MUNICIPAL CORPORATION, THE BOARD SHALL ADVISE THE MUNICIPAL CORPORATION IN WRITING OF THE ADDITIONAL INFORMATION WHICH IS REQUIRED FOR THE LOCAL BOARD TO PROVIDE A VOTER REGISTRATION LIST UNDER THIS SUBSECTION.

(ii) -- THE BOARD SHALL ADVISE THE MUNICIPAL CORPORATION IN WRITING IF THE BOARD IS UNABLE TO PROVIDE THE VOTER REGISTRATION LIST WITH THE EXCLUSIONS OR INCLUSIONS REQUESTED IN THE APPLICATION OF THE MUNICIPAL CORPORATION, AND THE REASON FOR THE INABILITY OF THE BOARD TO PROVIDE THE REQUESTED INCLUSIONS OR EXCLUSIONS.

(iii) -- IF REQUESTED BY THE MUNICIPAL CORPORATION, THE VOTER REGISTRATION LIST SHALL BE DIVIDED ACCORDING TO THE REGISTRANTS' MUNICIPAL POLLING PLACES.

(8) -- WITHIN 45 DAYS OF THE APPLICATION BY THE MUNICIPAL CORPORATION, THE BOARD AND THE LIAISON OF THE MUNICIPAL CORPORATION SHALL JOINTLY DEVELOP A WRITTEN SCHEDULE FOR THE TIMELY SUBMISSION OF INFORMATION BY THE MUNICIPAL CORPORATION TO THE LOCAL BOARD AND FOR THE TIMELY DELIVERY OF THE CERTIFIED VOTER REGISTRATION LIST FROM THE BOARD TO THE MUNICIPAL CORPORATION.
