

(9)--THE BOARD SHALL PROVIDE AT NO COST A CERTIFIED LIST OF REGISTERED VOTERS RESIDING WITHIN BOUNDARIES OF THE MUNICIPAL CORPORATION TO THE MUNICIPAL CORPORATION IN COMPLIANCE WITH THE AGREED UPON SCHEDULE REFERRED TO IN PARAGRAPH (8) OF THIS SUBSECTION.

(10)--WHEN THE MUNICIPAL CORPORATION HAS REQUESTED THE DATE OF BIRTH OF REGISTERED VOTERS ON THE CERTIFIED LIST, IT MAY EXCLUDE THOSE VOTERS WHO HAVE NOT REACHED THE AGE OF 18 AS OF THE DATE OF THE MUNICIPAL ELECTION.

(11)--UPON REQUEST BY THE MUNICIPAL CORPORATION, THE BOARD SHALL PROVIDE VOTER REGISTRATION FORMS TO THE MUNICIPAL CORPORATION.

(12)--A MUNICIPAL CORPORATION MAY REMOVE A VOTER'S NAME FROM ITS VOTER REGISTRATION LIST FOR PURPOSES OF MUNICIPAL ELECTIONS ONLY IF A VOTER HAS NOT VOTED IN A MUNICIPAL ELECTION WITHIN THE PAST 5 YEARS.

(13)--WHENEVER THE REGISTRATION OF ANY VOTER IS REMOVED FROM THE VOTER REGISTRATION LIST FOR ANY REASON, THE MUNICIPAL CORPORATION SHALL SEND A NOTICE OF THIS ACTION AND THE REASON FOR THE ACTION TO THE LAST KNOWN ADDRESS OF THE VOTER.

(14)-(i)--THE VOTER SHALL BE GIVEN 15 DAYS TO RESPOND TO INDICATE WHETHER THE VOTER WISHES TO REMAIN ON THE MUNICIPAL VOTER REGISTRATION LIST.

(ii)--IF THE VOTER WISHES TO REMAIN ON THE LIST, THE VOTER'S NAME MAY NOT BE REMOVED FROM THE MUNICIPALITY'S VOTER REGISTRATION LIST.

(15)--THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS SHALL ADOPT REGULATIONS TO IMPLEMENT THIS SUBSECTION AND RESOLVE DISPUTES AS TO THE ABILITY OF LOCAL BOARDS TO PROVIDE EXCLUSIONS OR INCLUSIONS ON THE VOTER REGISTRATION LIST AS REQUESTED BY THE MUNICIPAL CORPORATION.

(16)--THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS SHALL COOPERATE WITH THE BOARDS AND MUNICIPAL ELECTION OFFICIALS TO EFFECTUATE THE PROVISIONS OF THIS SUBSECTION.

(17)--THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A MUNICIPAL CORPORATION FROM ADMINISTERING AND MAINTAINING ITS OWN VOTER REGISTRATION LISTS AS LONG AS THOSE PERSONS LISTED ON THE CERTIFIED VOTER REGISTRATION LIST PROVIDED TO THE MUNICIPAL CORPORATION BY THE COUNTY BOARD OF ELECTIONS ARE INCLUDED ON THE OFFICIAL VOTER REGISTRATION LISTS OF THE MUNICIPAL CORPORATION AND ALLOWED TO VOTE IN THE MUNICIPAL CORPORATION'S ELECTIONS.
