

PONCA STREET; THENCE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF PONCA STREET NORTHERLY TO INTERSECT THE NORTHERN RIGHT-OF-WAY LINE OF BOSTON STREET; THENCE BINDING ON THE NORTHERN RIGHT-OF-WAY LINE OF BOSTON STREET EASTERLY TO INTERSECT THE WESTERN RIGHT-OF-WAY LINE OF THE BALTIMORE HARBOR TUNNEL THRUWAY; THENCE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF THE BALTIMORE HARBOR TUNNEL THRUWAY NORTHERLY TO INTERSECT THE SOUTHERN RIGHT-OF-WAY LINE OF O'DONNELL STREET; THENCE BINDING ON THE SOUTHERN RIGHT-OF-WAY LINE OF O'DONNELL STREET WESTERLY TO INTERSECT THE WESTERN RIGHT-OF-WAY LINE OF SOUTH CONKLING STREET; THENCE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF SOUTH CONKLING STREET SOUTHERLY TO INTERSECT THE NORTHERN RIGHT-OF-WAY LINE OF SOUTH CONKLING STREET SOUTHERLY TO INTERSECT THE NORTHERN RIGHT-OF-WAY LINE OF ELLIOT STREET; THENCE BINDING ON THE NORTHERN RIGHT-OF-WAY LINE OF ELLIOT STREET WESTERLY TO INTERSECT THE WESTERN RIGHT-OF-WAY LINE OF BAYLIS STREET; THENCE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF BAYLIS STREET SOUTHERLY TO INTERSECT THE NORTHERN PROPERTY LINE OF LOT 13/16, WARD 26, SECTION 2, BLOCK 6492; THENCE BINDING ON THE EXTENDED NORTHERN PROPERTY LINE OF SAID LOT 13/16 WESTERLY TO INTERSECT THE WESTERN RIGHT-OF-WAY LINE OF SOUTH HIGHLAND AVENUE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF SOUTH HIGHLAND AVENUE SOUTHERLY TO INTERSECT THE NORTHERN PROPERTY LINE OF LOT 18, WARD 26, SECTION 2, BLOCK 6491; THENCE BINDING ON THE EXTENDED PROPERTY LINE OF SAID LOT 18 WESTERLY TO INTERSECT THE WESTERN RIGHT-OF-WAY LINE OF WISE COURT; THENCE BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF WISE COURT NORTHERLY TO INTERSECT THE NORTHERN PROPERTY LINE OF LOT 44, WARD 26, SECTION 2, BLOCK 6491; THENCE BINDING ON THE NORTHERN PROPERTY LINE OF SAID LOT 44 WESTERLY TO THE POINT OF BEGINNING.

SECTION 2. AND BE IT FURTHER ENACTED, That the powers granted to the Mayor and City Council of Baltimore to petition for the immediate taking of property in Section 21-16 of the Code of Public Local Laws of Baltimore City (1979 Edition and 1983 Supplement, as amended) may not be exercised with regard to any property described in the provisions of Section ~~15(A)(a)(2)(iii)~~ ~~(15A)(a)(2)(iii)~~ of Article II of the Charter of Baltimore City as amended by this Act.

SECTION -2- 3. AND BE IT FURTHER ENACTED, That the provisions of Section (15A)(a)(2)(iii) of Article II of the Charter of Baltimore City as contained in this Act shall remain effective for a period of three years and, at the end of June 30, 1991, and with no further action required by the General Assembly, shall be abrogated and of no further force and effect. The abrogation of this provision, however, shall not effect affect any suit or suits at law filed pursuant to that provision on or before June 30, 1991.
