THERE IS A STATE ACTION LOANS FOR TARGETED AREAS PROGRAM IN THE DEPARTMENT.

4-503.

THE PURPOSES OF THE PROGRAM ARE TO PROVIDE FINANCIAL ASSISTANCE FOR THE PURPOSE OF:

- (1) CREATE CREATING HOUSING AND JOBS IN TARGETED AREAS THROUGH SUPPORT OF PRIVATE SECTOR INITIATIVES:
- (2) PROMOTE PROMOTING COMMERCIAL REDEVELOPMENT AND ECONOMIC REVITALIZATION EFFORTS IN TARGETED AREAS;
- (3) SUPPORT <u>SUPPORTING</u> RETENTION OF HOUSING STOCK AND EXISTING BUSINESSES:
- (4) PROVIDE PROVIDING A SOURCE OF FUNDS FOR EMERGENCY HOUSING AND BUSINESS ASSISTANCE;
- (5) SUPPORT SUPPORTING DEVELOPMENT EFFORTS FOR PROJECTS UNDERTAKEN JOINTLY BY THE PUBLIC AND PRIVATE SECTORS; AND
- (6) PROVIDE PROVIDING FINANCIAL ASSISTANCE FOR PROJECTS WHICH WOULD NOT BE UNDERTAKEN OTHERWISE. 4-504.

THE DEPARTMENT SHALL:

- (1) MANAGE, SUPERVISE, AND ADMINISTER THE PROGRAM;
- (2) ADOPT POLICIES <u>REGULATIONS</u> TO ENSURE THAT FINANCIAL ASSISTANCE IS PROVIDED TO PROJECTS THAT CARRY OUT THE PURPOSES OF THE PROGRAM:
- (3) ATTACH SPECIFIC TERMS TO ANY FORM OF FINANCIAL ASSISTANCE AS MAY BE NECESSARY TO ASSURE THE PURPOSES OF THE PROGRAM ARE FULFILLED; AND
- (4) DEVELOP PROCEDURES FOR MONITORING COMPLIANCE BY THE ULTIMATE RECIPIENTS OF FINANCIAL ASSISTANCE WITH THE CONDITIONS OF ANY FINANCIAL ASSISTANCE.

4-505.

- (A) (1) A COUNTY OR MUNICIPALITY MUST FILE APPLICATIONS FOR FINANCIAL ASSISTANCE ON BEHALF OF A PROJECT.
- (2) A COUNTY MAY APPLY FOR FINANCIAL ASSISTANCE ON BEHALF OF A PROJECT WITHIN A MUNICIPALITY BUT ONLY WITH-THE CONSENT AT THE REQUEST OF THE MUNICIPALITY.
