For a procurement solicited after January 1, 1987 and costing more than \$100,000, the bidder or offeror shall certify at the time the ~~{procurement contract is awarded}~~ PUBLIC-BODY AWARDS-THE-CONTRACT that:

(1) the bidder or offeror is not doing business with or in the Republic of South Africa OR NAMIBIA OR KNOWINGLY SUBCONTRACTING WITH AN ENTITY THAT DOES SO ; or

(2) in the conduct of operations in the Republic of South Africa OR NAMIBIA, the bidder or offeror, OR, IF APPLICABLE, THE SUBCONTRACTOR:

(i) maintains nonsegregation of the races in all eating, comfort, and work facilities and locker rooms;

(ii) promotes equal and fair employment practices for all employees;

(iii) provides equal pay for all employees doing equal or comparable work for the same period of time;

(iv) initiates and develops training programs that will prepare a substantial number of Blacks, Asians, and
