SECTION 2. AND BE IT FURTHER ENACTED, That the moneys credited to the Law Enforcement and Correctional Training Fund under this Act shall be used exclusively by the Department of Public Safety and Correctional Services for funding capital projects on a pay-as-you-go basis, as reflected each year in the Department's operating budget beginning in Fiscal Year 1990, or a lease agreement as approved by the Budget Committees, for the purposes of design, equipping, and construction of the Public Safety Training Center.
