 - (2)--FOR-EACH-DEER,-\$200;
 - (3)--FOR-EACH-WILD-TURKEY,-HAWK,-OR-OWL,-\$100;
 - (4)--FOR-EACH-BEAVER;-OTTER;-MINK;-OR-WILD-GOOSE;-\$25;
- (5)--FOR-EACH-DUCK,-RABBIT,-SQUIRREL,-OPPOSSUM,-QUAIL, WOODCOCK,-GROUSE,-OR-PHEASANT,-\$10;-AND
- (6)--FOR--ANY--OTHER--WILDLIFE-OR-PROTECTED-SPECIES-OF ANIMAL7-\$10.
- THE DEPARTMENT SHALL, BY REGULATION, ESTABLISH A SCHEDULE OF RESOURCE VALUES FOR INDIVIDUAL SPECIES OR DESCRIBE A SYSTEM THAT A COURT MAY USE IN DETERMINING THE RESOURCE VALUE FOR THE SPECIES.
