BE IT ENACTED BY THE GENERAL ASSEMBLY OF SECTION 1. MARYLAND, That the Laws of Maryland read as follows:

BREATHES OR SHOWS ANY OTHER EVIDENCE OF LIFE, SUCH AS HEARTBEAT PULSATION OF THE UMBILICAL CORD, OR DEFINITE MOVEMENT OF VOLUNTARY MUSCLE, WHETHER OR NOT THE UMBILICAL CORD IS CUT OR THE PLACENTA IS ATTACHED.
