EACH SUM OF MONEY GIVEN BY EACH INDIVIDUAL WHO PURCHASES A SPIN OR CHANCE ON THE PADDLE WHEEL OR WHEEL OF FORTUNE AUTHORIZED BY LAW TO BE OPERATED IN THE STATE AT A CAMPAIGN FUND-RAISING EVENT IF:

- THE PADDLE WHEEL OF FORTUNE DOES NOT EXCEED \$2;
- COMMITTEE OR A PARTISAN ORGANIZATION FROM PADDLE WHEELS OR WHEELS OF FORTUNE DO NOT EXCEED \$2,500 PER ELECTION;
- (111) THE NET INCOME TO THE SPONSORING POLITICAL COMMITTEE OR PARTISAN ORGANIZATION FROM A PADDLE WHEEL OR WHEEL OF FORTUNE DOES NOT EXCEED \$1,500 IN A 24-HOUR PERIOD AT A SINGLE FUND-RAISING EVENT; AND
- $+\pm\pm$) (1V) THE ACCOUNT BOOKS INCLUDE THE TOTAL NET AMOUNT RECEIVED AND THE NAMES AND ADDRESSES OF THE INDIVIDUALS WHO ATTEND THE FUND-RAISING EVENT AT WHICH THE WHEEL IS USED.
- (4) IF A POLITICAL COMMITTEE OR PARTISAN ORGANIZATION RAISES OR RECEIVES CONTRIBUTIONS FROM A PADDLE WHEEL OR WHEEL OF FORTUNE IN EXCESS OF ANY OF THE LIMITATIONS ESTABLISHED IN PARAGRAPH (3) OF THIS SUBSECTION, THE POLITICAL COMMITTEE OR PARTISAN ORGANIZATION SHALL:
- CHARITY OF 1TS CHOICE; OR
- (11) IDENTIFY IN THE ACCOUNT BOOKS EACH SUM OF MONEY GIVEN BY EACH INDIVIDUAL WHO PURCHASES A SPIN OR CHANCE ON THE PADDLE WHEEL OR WHEEL OF FORTUNE AUTHORIZED BY LAW TO BE OPERATED IN THE STATE AT A CAMPAIGN FUND-RAISING EVENT.
- +4+ +(5) THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS SHALL ADOPT REGULATIONS NECESSARY TO IMPLEMENT THIS SUBSECTION.
- (c) [Any] EXCEPT AS PROVIDED IN SUBSECTION (A) OF THIS SECTION, ANY money or other thing of value received from any unknown person or source by any treasurer or any subtreasurer, or other persons or committee authorized to incur obligations or to pay or defray obligations or expenses under the provisions of this article, shall not be used for any political purpose whatsoever, but shall be paid by the treasurer, subtreasurer, or other persons or committee so receiving the same, to the Treasurer of the State of Maryland.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1988.
