- 2-101. NUMBER; COMPENSATION.
- (A) NUMBER. THERE ARE 5 COUNTY COMMISSIONERS FOR SOMERSET COUNTY, WHO HOLD OFFICE FOR 4 YEARS AND UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.
- (B) SALARY. EACH COMMISSIONER SHALL RECEIVE AN ANNUAL SALARY OF \$3,750.
- (C) EXPENSES. EACH COMMISSIONER MAY RECEIVE REIMBURSEMENT OF NO MORE THAN \$1,500 A YEAR FOR FOOD AND MILEAGE EXPENSES FOR ANY OFFICIAL DUTIES. THE COUNTY COMMISSIONER SHALL SUBMIT A REIMBURSEMENT VOUCHER FOR EACH EXCURSION, SIGNED BY 3 OF THE 5 COMMISSIONERS. DISTRICT 1 BEGINS AT THE SOUTHWEST CORNER OF ELECTION DISTRICT 4 (DUBLIN), AS IT EXISTS ON MAY 28, 1986, AT THE INTERSECTION OF THE POCOMOKE RIVER AND A DIRECT LINE EXTENDING FROM THE END OF GORDY ROAD. THE LINE GOES NORTH ALONG BOUNDARY BETWEEN CURRENT ELECTION DISTRICTS 4 AND 13 (WESTOVER) TO THE INTERSECTION OF MENNONITE CHURCH ROAD AND TURKEY BRANCH ROAD. WEST ON TURKEY BRANCH ROAD TO MARION ROAD. NORTH ON MARION ROAD TO ROUTE 413. SOUTH ON ROUTE 413 WEST ON ROUTE 361 TO MILLARD LONG ROAD. NORTH ON MILLARD LONG ROAD TO REVELLS NECK ROAD. EAST ON REVELLS NECK ROAD TO STEWART NECK ROAD. NORTHEAST ON STEWART NECK ROAD TO KINGS CREEK, FORMING THE BOUNDARY BETWEEN CURRENT ELECTION DISTRICTS 1 (WEST PRINCESS ANNE) AND 13. WEST ALONG THE BOUNDARY TO GOOSE CREEK. NORTH AND NORTHWEST ON GOOSE CREEK, FORMING THE BOUNDARY BETWEEN CURRENT ELECTION DISTRICTS 1 AND 2 (ST. PETERS) TO THE INTERSECTION OF THE BOUNDARY AND EBBY ROAD AT LITTLE MONIE CREEK, NORTH OF VENTON. NORTH ON EBBY ROAD TO ITS END. NORTH ON A LINE EXTENDING FROM THE END OF EBBY ROAD TO THE INTERSECTION WITH MONIE CREEK, FORMING THE BOUNDARY BETWEEN CURRENT ELECTION DISTRICTS 1 AND 5 (MT. VERNON). EAST AND THEN NORTH ALONG THIS BOUNDARY TO RIDGE ROAD. SOUTH ON RIDGE ROAD TO ROUTE 362. EAST ROUTE 362 TO SHERREE LANE. SOUTH ON SHERREE LANE TO ITS END. EAST ON THE UNNAMED STREET AT THE END OF SHERREE LANE TO CRISFIELD LANE. SOUTH ON CRISFIELD LANE TO ROUTE 363. EAST ON ROUTE 363 TO U.S. 13. SOUTH ON U.S. 13 TO LINDEN AVENUE. EAST
