

(2) THERE IS A BASIC HUNTING LICENSE WHICH AUTHORIZES THE PURCHASER TO HUNT ALL LEGAL GAME EXCEPT DEER AND WATERFOWL.

(3) (I) THERE IS A SENIOR LIFETIME HUNTING LICENSE FOR RESIDENTS WHO ARE AT LEAST 65 YEARS OLD.

(II) THE SENIOR LIFETIME HUNTING LICENSE AUTHORIZES THE PURCHASER TO HUNT BIG GAME IN EACH HUNTING SEASON IN THE STATE, INCLUDING BOW AND ARROW, BLACK POWDER, AND REGULAR FIREARMS SEASON.

(4) THE FEES FOR HUNTING LICENSES ARE ACCORDING TO THE FOLLOWING SCHEDULE:

(I) RESIDENT, UNDER THE AGE OF 16 YEARS:

- 1. BASIC HUNTING LICENSE.....\$ 6.50
- 2. CONSOLIDATED HUNTING LICENSE....\$15.50

(II) RESIDENT, AT LEAST 16 YEARS OLD AND UNDER THE AGE OF 65 YEARS:

- 1. BASIC HUNTING LICENSE.....\$15.50
- 2. CONSOLIDATED HUNTING LICENSE....\$24.50

(III) SENIOR LIFETIME LICENSE FOR RESIDENTS AT LEAST 65 YEARS OLD.....\$12.50
