- (II)--ANY--NUMERICAL--DESIGNATION--USED--BY--THE VIDEOTAPE-DISTRIBUTOR-TO-IDENTIFY-THE-PROTECTED-INDIVIDUAL;-AND
- (2)--AN--INDIVIDUAL-OR---SUMMARY---BISTING---OP---ANY VIDEOTAPES-PURCHASED-OR-RENTED-BY-THE-A-PROTECTED-INDIVIDUAL-PROM THE--VIDEOTAPE--DISTRIBUTOR: AN INDIVIDUAL WHO BUYS, RENTS, OR BORROWS A VIDEOTAPE, VIDEODISK, OR FILM FROM A VIDEOTAPE DISTRIBUTOR.

- (4) "VIDEOTAPE DISTRIBUTOR" MEANS A RETAIL ESTABLISHMENT OPERATING FOR PROFIT THAT SELLS, RENTS, OR LOANS VIDEOTAPES, VIDEODISKS, OR FILMS.
- (B) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A VIDEOTAPE DISTRIBUTOR OR AN AGENT, SERVANT, OR EMPLOYEE OF A VIDEOTAPE DISTRIBUTOR MAY NOT PUBLISH THE FOLLOWING INFORMATION RELATING TO SALES, RENTALS, OR LOANS OF VIDEOTAPES, VIDEODISKS, OR FILMS TO ANY PROTECTED INDIVIDUAL:
- DISTRIBUTOR TO IDENTIFY THE PROTECTED INDIVIDUAL; OR
- VIDEOTAPES, VIDEODISKS, OR FILMS PURCHASED, RENTED, OR BORROWED BY THE PROTECTED INDIVIDUAL FROM THE VIDEOTAPE DISTRIBUTOR.
- (C) THIS SECTION DOES NOT PROHIBIT THE DISTRIBUTION OF INFORMATION PROTECTED UNDER SUBSECTION (B) OF THIS SECTION TO:
- (1) ANY PERSON DESIGNATED BY THE VIDEOTAPE DISTRIBUTOR WHOM THE PROTECTED INDIVIDUAL AUTHORIZES, PRIOR TO DISTRIBUTION, TO RECEIVE THE INFORMATION;
- PERSONNEL; OR PPROPRIATELY AUTHORIZED LAW ENFORCEMENT
- BY THE VIDEOTAPE DISTRIBUTOR TO COLLECT UNRETURNED RENTAL VIDEOTAPES, VIDEODISKS, OR FILMS, OR AN AMOUNT EQUAL TO THE VALUE OF THE UNRETURNED VIDEOTAPES, VIDEODISKS, OR FILMS.
