[(j)] (K) "Restricted license" means a license issued by the Board under and as limited by § 13-314 of this title to practice physical therapy.

[(k)] (L) "Temporary license" means a license issued by the Board under and as limited by § 13-313 of this title to practice:

- (1) Physical therapy; or
- (2) Limited physical therapy.

SUBTITLE 3A. THE PHYSICAL THERAPIST  
REHABILITATION COMMITTEE

13-3A-01.

(A) FOR PURPOSES OF THIS SUBTITLE, THERE IS A PHYSICAL THERAPIST REHABILITATION COMMITTEE UNDER THE AMERICAN PHYSICAL THERAPY ASSOCIATION OF MARYLAND, INC., THAT IS:

- (1) RECOGNIZED BY THE BOARD; AND
- (2) COMPOSED OF PHYSICAL THERAPISTS.

(B) ON REQUEST, THE COMMITTEE SHALL EVALUATE AND PROVIDE ASSISTANCE TO ANY PHYSICAL THERAPIST OR PHYSICAL THERAPIST ASSISTANT IN NEED OF TREATMENT AND REHABILITATION FOR ALCOHOLISM, DRUG ABUSE, CHEMICAL DEPENDENCY, OR OTHER PHYSICAL, EMOTIONAL, OR MENTAL CONDITIONS.

(C) (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, THE PROCEEDINGS, RECORDS, AND FILES OF THE COMMITTEE ARE NOT DISCOVERABLE AND ARE NOT ADMISSIBLE INTO EVIDENCE IN ANY CIVIL ACTION ARISING OUT OF MATTERS THAT ARE BEING OR HAVE BEEN REVIEWED AND EVALUATED BY THE COMMITTEE.

(2) PARAGRAPH (1) OF THIS SUBSECTION DOES NOT APPLY TO ANY RECORD OR DOCUMENT THAT IS CONSIDERED BY THE COMMITTEE, AND THAT OTHERWISE WOULD BE DISCOVERABLE AND WOULD BE ADMISSIBLE INTO EVIDENCE IN A CIVIL ACTION.

(3) FOR PURPOSES OF THIS SUBSECTION, CIVIL ACTION DOES NOT INCLUDE A PROCEEDING BEFORE THE BOARD OR THE JUDICIAL REVIEW OF A PROCEEDING BEFORE THE BOARD.

(D) A PERSON WHO ACTS IN GOOD FAITH AND WITHIN THE SCOPE OF THE JURISDICTION OF THE COMMITTEE IS NOT CIVILLY LIABLE FOR ANY ACTION AS A MEMBER OF THE COMMITTEE OR FOR GIVING INFORMATION TO, PARTICIPATING IN, OR CONTRIBUTING TO THE FUNCTION OF THE COMMITTEE.
