- (5) A---PERSON AN INDIVIDUAL POSSESSING A MASTER ELECTRICIAN'S LICENSE ISSUED BY THE STATE OR ANY COUNTY, WHEN ENGAGED IN THE INSTALLATION, SERVICE, REPAIR, OR REPLACEMENT OF INDIVIDUALLY-CONTROLLED ELECTRIC RESISTANCE HEAT;
- (6) A--PERSON AN INDIVIDUAL POSSESSING A MASTER PLUMBER'S LICENSE ISSUED BY THE STATE, --WHEN--ENGAGED-IN-THE INSTALLATION, -SERVICE, -REPAIR, -OR-REPLACEMENT-OP-HYDRONIC-HEATING SYSTEMS; OR
- (7)--AN-APPRENTICE-WHO-IS-REGISTERED-WITH--THE-BOARD AND--WORKING--UNDER--THE-CONTROL-AND-DIRECTION-OF-A-PERSON-WITH-A MASTER-OR-MASTER-RESTRICTED-LICENSE:
- (7) AN INDIVIDUAL REGULARLY EMPLOYED BY THE OWNER OF PROPERTY OR THE OWNER'S AGENT TO ENGAGE IN MAINTENANCE AND REPAIR WORK COVERED BY THIS SUBTITLE.
- (8) AN INDIVIDUAL WHO PROVIDES SERVICES AS AN EMPLOYEE OR SUBORDINATE OF A MASTER OR MASTER RESTRICTED LICENSEE IF:
- (I) THE INDIVIDUAL PROVIDES HEATING, VENTILATION, AIR CONDITIONING, OR REFRIGERATION SERVICES WHILE UNDER THE CONTROL OF THE LICENSEE; AND
- (II) THE LICENSEE IS RESPONSIBLE FOR THE HEATING, VENTILATION, AIR CONDITIONING, OR REFRIGERATION SERVICES THAT THE INDIVIDUAL PROVIDES.
