## 5-315. SCOPE OF LICENSES.

- (A) LICENSES TO PRACTICE.
- (1) SUBJECT TO PARAGRAPHS (2) THROUGH (6) OF THIS SUBSECTION AND WHILE A LICENSE TO PRACTICE COSMETOLOGY IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PRACTICE COSMETOLOGY.
- (2) WHILE A LIMITED LICENSE TO PROVIDE DEMONSTRATING SERVICES IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PROVIDE ONLY DEMONSTRATING SERVICES.
- (3) WHILE A LIMITED LICENSE TO PROVIDE ESTHETIC SERVICES IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PROVIDE ONLY ESTHETIC SERVICES.
- (4) WHILE A LIMITED LICENSE TO PROVIDE MANICURING SERVICES IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PROVIDE ONLY MANICURING SERVICES.
- (5) WHILE A LIMITED LICENSE TO PROVIDE WIG STYLING SERVICES IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PROVIDE ONLY WIG STYLING SERVICES.
- (6) WHILE A COSMETOLOGIST-AIDE LICENSE IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PRACTICE COSMETOLOGY:
- (I) UNDER THE SUPERVISION OF AN INDIVIDUAL LICENSED TO MANAGE A BEAUTY SALON IN A BEAUTY SALON THAT HOLDS A BEAUTY SALON PERMIT; AND

## (II) RESTRICTED TO:

- 1. SHAMPOOING:
- 2. REMOVING NETS, ROLLERS, CLIPS, PINS, PERMANENT WAVE SOLUTIONS, NEUTRALIZERS, STABILIZERS, HAIR RELAXERS, WAVING RODS, TINTS, OR BLEACHES;
  - 3. STERILIZING EQUIPMENT; AND
  - 4. SIMILAR ACTIVITIES.
  - (B) LICENSES TO TEACH.
- (1) SUBJECT TO PARAGRAPHS (2) THROUGH (5) OF THIS SECTION AND WHILE A LICENSE TO TEACH COSMETOLOGY IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO TEACH COSMETOLOGY IN A COSMETOLOGY SCHOOL THAT HOLDS A SCHOOL PERMIT.
- (2) WHILE A LICENSE TO TEACH COSMETOLOGY LIMITED TO PROVIDING ESTHETIC SERVICES IS IN EFFECT, THE LICENSE AUTHORIZES
