

(3)--AT-THE-HEARING-THE-OWNER-SHALL-BEAR-THE-BURDEN-OF-PROVING-ANY-DEFENSES-PROVIDED.

(E)--THE-TERMS-OF-THE-SUSPENSION-AND-IMPOUNDMENT-OF-AN-OWNER'S-REGISTRATION-PLATES-AND-CARD-SHALL-BE-AS-FOLLOWS:

(1)--THE-REGISTRATION-PLATES-AND-CARD-MAY-NOT-BE-RETURNED-TO-A-VIOLATOR-WHO-IS-THE-OWNER-OR-JOINT-OWNER-UNTIL:

(I)--THE-DRIVER'S-LICENSE-OF-THE-VIOLATOR-HAS-BEEN-RESTORED-AFTER-ANY-SUBSEQUENTLY-IMPOSED-LICENSE-REVOCATION-OR-SUSPENSION; AND

(II)--THE-VIOLATOR-PAYS-ANY-FEES-OWED-TO-THE-ADMINISTRATION; AND

(2)--IN-THE-CASE-OF-AN-OWNER-WHO-IS-NOT-THE-VIOLATOR, THE-REGISTRATION-PLATES-AND-CARD-MAY-NOT-BE-RETURNED:

(I)--FOR-A-PERIOD-OF-120-DAYS; AND

(II)--PROVIDED-THE-OWNER-PAYS-ANY-FEES-OWED-TO-THE-ADMINISTRATION.

(F)-(1)--AN-OWNER-MAY-APPLY-TO-THE-ADMINISTRATION-FOR-SPECIAL-REGISTRATION-PLATES-WHICH-BEAR-A-SERIES-OF-NUMBERS-OR-LETTERS-READILY-IDENTIFIABLE-TO-LAW-ENFORCEMENT-OFFICERS.

(2)--THE-ADMINISTRATION-MAY-ISSUE-SPECIAL-REGISTRATION-PLATES-IF-AN-OWNER-OR-A-MEMBER-OF-THE-OWNER'S-HOUSEHOLD-HAS-A-VALID-DRIVER'S-LICENSE.

(3)--THE-ADMINISTRATION-SHALL-COLLECT-A-FEE-OF-\$35-FOR-EACH-VEHICLE-FOR-WHICH-SPECIAL-PLATES-ARE-ISSUED.

(G)--BEFORE-THE-RETURN-OF-THE-REGISTRATION-PLATES-AND-CARD-WHICH-HAVE-BEEN-SUSPENDED-AND-IMPOUNDED-UNDER-THIS-SECTION, THE-ADMINISTRATION-SHALL-COLLECT-A-FEE-OF-\$35.

(H)-(1)--EXCEPT-AS-PROVIDED-IN-PARAGRAPH-(3)-OF-THIS-SUBSECTION, UNLESS-THE-OWNER-APPLIES-TO-THE-ADMINISTRATION-FOR-PERMISSION-TO-TRANSFER-TITLE-TO-THE-MOTOR-VEHICLE, AN-OWNER-MAY-NOT-TRANSFER-OR-SELL-A-MOTOR-VEHICLE-DURING-THE-TIME-ITS-REGISTRATION-PLATES-AND-CARD-HAVE-BEEN-SUSPENDED-AND-IMPOUNDED-OR-DURING-THE-TIME-THE-VEHICLE-DISPLAYS-SPECIAL-REGISTRATION-PLATES-UNDER-SUBSECTION-(D)-OF-THIS-SECTION;

(2)--UPON-APPLICATION, THE-ADMINISTRATION-SHALL-ISSUE-A-TITLE-AND-REGISTRATION-TO-THE-NEW-OWNER-IF:

(I)--THE-ADMINISTRATION-IS-SATISFIED-THAT-THE-PROPOSED-TRANSFER-OR-SALE-IS-IN-GOOD-FAITH;
