- (II) A PROVISION DESCRIBED UNDER SUBPARAGRAPH OF THIS PARAGRAPH EXPRESSLY PROHIBITING THE USE OF A UNIT AS A FAMILY DAY CARE HOME SHALL APPLY TO AN EXISTING FAMILY DAY CARE HOME IN THE CONDOMINIUM.
