- D. INITIATION AND DEVELOPMENT OF TRAINING PROGRAMS THAT WILL PREPARE SUBSTANTIAL NUMBERS OF BLACK AND OTHER NONWHITE PERSONS FOR SUPERVISORY, ADMINISTRATIVE, CLERICAL, AND TECHNICAL JOBS;
- E. INCREASING THE NUMBER OF BLACKS, COLOUREDS, AND ASIANS IN MANAGEMENT AND SUPERVISORY POSITIONS; AND
- F. IMPROVEMENT IN THE QUALITY OF EMPLOYEES' LIVES OUTSIDE THE WORK ENVIRONMENT INCLUDING, BUT NOT LIMITED TO, THE AREAS OF HOUSING, TRANSPORTATION, EDUCATION, RECREATION, AND HEALTH CARE; AND
- 2. IS A SIGNATORY TO THESE PRINCIPLES OR HAS DEMONSTRATED THAT IT IS MAKING PROGRESS OR GOOD PROGRESS IN IMPLEMENTING THESE PRINCIPLES.
- (C) (1) ANY FUNDS DEPOSITED OR INVESTED BEFORE JULY 1, 1989 OR DURING THE PERIOD OF ANY SUSPENSION UNDER THIS SUBSECTION AND WHICH REMAIN DEPOSITED OR INVESTED ON OR AFTER JULY 1, 1989 IN ANY BANKS, FINANCIAL INSTITUTIONS, COMPANIES, OR THEIR SUBSIDIARIES OR AFFILIATES DESCRIBED IN SUBSECTION (B) OF THIS SECTION SHALL BE WITHDRAWN OR DIVESTED ON OR BEFORE THE DEADLINE FOR COMPLETE DIVESTITURE, AS MAY BE EXTENDED UNDER THIS SUBSECTION.
- (2) THE DEADLINE FOR COMPLETE DIVESTITURE IS JULY 1, 1991.
- (3) BEGINNING JULY 1, 1989, THE WSSC SHALL MAKE SEMIANNUAL REPORTS TO THE GOVERNOR, THE LEGISLATIVE POLICY COMMITTEE OF THE GENERAL ASSEMBLY, THE PRINCE GEORGE'S COUNTY AND MONTGOMERY COUNTY DELEGATIONS, AND THE PRINCE GEORGE'S COUNTY AND MONTGOMERY COUNTY EXECUTIVES ON THE PROGRESS OF DIVESTITURE UNTIL THE DIVESTITURE IS COMPLETED.
- (4) THE WSSC MAY FROM TIME TO TIME SUSPEND THE DIVESTITURE PROGRAM AND EXTEND THE DEADLINE FOR COMPLETE DIVESTITURE IF THE WSSC DETERMINES THAT:
- (I) CONTINUED DIVESTITURE UNDER THIS SUBSECTION AND COMPLIANCE WITH THE PROHIBITION UNDER SUBSECTION (B) OF THIS SECTION WILL BE INCONSISTENT WITH GENERALLY ACCEPTED FIDUCIARY STANDARDS FOR TRUSTEES OF PENSION FUNDS; OR
- (II) DIVESTITURE AND CONTINUED COMPLIANCE WITH THE PROHIBITION UNDER SUBSECTION (B) OF THIS SECTION WILL CAUSE CONTINUING FINANCIAL LOSSES TO THE FUNDS.
- (5) BEFORE ANY SUSPENSION OF THE DIVESTITURE PROGRAM UNDER THIS SUBSECTION, THE WSSC SHALL ADOPT AND SEND TO THE GOVERNOR, THE LEGISLATIVE POLICY COMMITTEE, THE PRINCE GEORGE'S
