

CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.

(C) SPECIAL REGISTRATION PLATES ISSUED UNDER THIS SECTION:

(1) MAY CONSIST OF ANY COMBINATION OF LETTERS, NUMERALS, OR BOTH; AND

(2) SHALL INCLUDE:

(I) A REPRESENTATION OF A PURPLE HEART MEDAL AND RIBBON;

(II) THE WORDS "COMBAT WOUNDED" PRINTED ACROSS THE BOTTOM OF THE PLATES; AND

(III) THE LETTER "P" SITUATED ABOVE THE LETTER "H", PRINTED ON THE PLATES ADJACENT TO THE INSIGNIA DESCRIBED IN ITEM (2)(I) OF THIS SUBSECTION.

13-619.1.

(A) A SPECIAL REGISTRATION NUMBER AS SPECIFIED BY THE ADMINISTRATION AND ASSIGNED UNDER § 13-614 OR § 13-619 OF THIS SUBTITLE MAY CONSIST OF:

(1) ANY COMBINATION OF LETTERS, NUMERALS, OR BOTH;

(2) THE NAME, INITIALS, OR ABBREVIATION OF THE NAME OF THE ORGANIZATION; AND

(3) ANY EMBLEM OR LOGO, APPROVED AND AUTHORIZED BY THE ADMINISTRATION, THAT DEPICTS THE ORGANIZATION.

(B) AN OWNER OF A VEHICLE ASSIGNED A SPECIAL REGISTRATION UNDER § 13-614 OR § 13-619 OF THIS SUBTITLE WHICH DISPLAYS AN EMBLEM OR LOGO AS AUTHORIZED UNDER THIS SECTION SHALL PAY AN ANNUAL FEE OF \$25 IN ADDITION TO THE ANNUAL REGISTRATION FEE OTHERWISE REQUIRED UNDER THIS TITLE.

(C) (1) THE ADMINISTRATION SHALL KEEP \$15 OF THE \$25 FEE FOR THE PURPOSE OF RECOVERING ITS COST UNDER THIS SECTION.

(2) FUNDS KEPT BY THE ADMINISTRATION UNDER THIS SUBSECTION MAY NOT BE CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply to the issuance of registration plates when the current multiyear registration plates expire, and the Motor Vehicle Administration is not required to reclaim or reissue
