ISSUED OR HAS been refused, suspended or revoked by the Commission.

[27A.

Notwithstanding any other provisions of this article, the Cape Pine Development Corporation is hereby authorized to conduct trotting and pacing races commonly known as matinee or exhibition racing at Cape Pine Farm in Church Hill, Queen Anne's County on not more than 5 days a month and for not more than a total of 30 days in any one calendar year. No pari-mutuel betting or wagering of any nature shall be allowed at such races; and the maximum prize or award that may be granted in any race shall not exceed three hundred dollars (\$300.00) in value.

SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

Article 18B - Racing Commission

FOR THE PURPOSES OF SUBSECTION (1) OF THIS SECTION, AN ARABIAN BREED HORSE IS A HORSE THAT:

- (1) IS A PUREBRED ARABIAN:
- (2) HAS A VALID CERTIFICATE OF REGISTRATION WITH THE RSE REGISTRY OF AMERICA OR THE CANADIAN ARABIAN HORSE ARABIAN HORSE REGISTRY, OR BOTH; AND
- SUPPLEMENT . (3) HAS AN ARABIAN JOCKEY CLUB IDENTIFICATION
- (1) (1) A LICENSEE UNDER § 7 OF THIS ARTICLE MAY CONDUCT RACES OF ARABIAN BREED HORSES AS PROVIDED IN THIS SUBSECTION.
- (2) (I) A LICENSEE MAY NOT CONDUCT MORE THAN 1 ARABIAN BREED HORSES PER RACING DAY. THE RACE SHALL BE IN ADDITION TO THE REGULAR NUMBER OF RACES CONDUCTED FOR THOROUGHBRED HORSES PER RACING DAY AND MAY NOT REPLACE AN EXISTING THOROUGHBRED RACE NOR REDUCE THE NUMBER OF THOROUGHBRED RACES CONDUCTED BY THE LICENSEE PER RACING DAY.
- (11) NOTWITHSTANDING THE **PROVISIONS** OF THIS SECTION, THE PORTION OF THE MUTUEL POOLS SUBSECTION (B) ALLOCATED FOR PURSES RESULTING FROM RACES OF ARABIAN BREED HORSES SHALL BE DISTRIBUTED AS FOLLOWS:
- EXCEPT AS PROVIDED IN ITEM 4 OF THIS SUBPARAGRAPH, THE FORMULA FOR THE ALLOCATION FOR EACH OF THE MUTUEL POOLS SHALL BE THE SAME AS FOR THOROUGHBRED HORSES UNDER SUBSECTION (B) OF THIS SECTION;
