

2. THE AMOUNT OF THE ALLOCATION FOR PURSES SHALL BE CREDITED TO THE PURSE ACCOUNT FOR ARABIAN BREED HORSES;

3. THE FORMULA FOR THE DISTRIBUTION OF THE PURSE MONEY, INCLUDING THE AMOUNT ALLOCATED FOR STAKES RACES, SHALL BE DETERMINED BY THE LICENSEE; AND

4. AN AMOUNT EQUAL TO NOT LESS THAN 1 PERCENT NOR MORE THAN 2 PERCENT OF OPEN PURSES FOR RACES OF ARABIAN BREED HORSES, AS DETERMINED BY THE ORGANIZATION REPRESENTING THE ARABIAN BREED RECOGNIZED BY THE LICENSEE, SHALL BE DEDUCTED FROM ALL OPEN PURSES AND PAID TO THE ORGANIZATION.

(III) WAGERING ON A RACE OF ARABIAN BREED HORSES MAY NOT BE COMBINED WITH WAGERING ON ANY OTHER RACE TO CONSTITUTE A MULTIPLE RACE WAGERING POOL.

(IV) EXCEPT AS PROVIDED IN SUBPARAGRAPH (V) OF THIS PARAGRAPH, ANY UNDERPAYMENT OR OVERPAYMENT OF PURSE MONEY FOR ARABIAN BREED HORSES IN A RACE MEETING SHALL BE CARRIED FORWARD TO THE NEXT RACE MEETING OF THE SAME LICENSEE OR, IF AGREED TO BY SUCH LICENSEES, THE NEXT RACE MEETING OF ANOTHER LICENSEE.

(V) IF THERE EXISTS AN UNDERPAYMENT OR OVERPAYMENT OF PURSE MONEY FOR ARABIAN BREED HORSES FROM A PREVIOUS RACE MEETING OF A LICENSEE AND NO RACES OF ARABIAN BREED HORSES ARE SCHEDULED FOR THE CURRENT RACE MEETING OF THE LICENSEE, THE LICENSEE:

1. MAY NOT CHARGE AN OVERPAYMENT TO THE THOROUGHBRED PURSE ACCOUNT;

2. SHALL RESOLVE THE DISPOSITION OF THE UNDERPAYMENT OR OVERPAYMENT THROUGH AN AGREEMENT WITH THE REPRESENTATIVE OF THE ORGANIZATION REPRESENTING THE ARABIAN BREED RECOGNIZED BY THE LICENSEE; AND

3. IF AN UNDERPAYMENT IS NOT DISTRIBUTED TO OWNERS OF ARABIAN BREED HORSES OR THE REPRESENTATIVE OF THE ORGANIZATION REPRESENTING THE ARABIAN BREED RECOGNIZED BY THE LICENSEE, SHALL CREDIT THE AMOUNT OF THE UNDERPAYMENT TO THE THOROUGHBRED PURSE ACCOUNT.

SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:
