

(III) USES THE SAME SERVICE WATER SUPPLY PIPE TO THE DWELLING UNIT THAT THE DOMESTIC PUBLIC WATER SYSTEM USES;

(IV) MEETS THE REQUIREMENTS OF CURRENT NATIONAL FIRE PROTECTION ASSOCIATION STANDARDS; AND

(V) IS APPROVED BY THE STATE FIRE MARSHAL OR THE LOCAL AUTHORITY HAVING JURISDICTION OVER THE ENFORCEMENT OF FIRE CODES.

~~(8)~~ (9) "TOWNHOUSE" MEANS A SINGLE FAMILY DWELLING UNIT CONSTRUCTED IN A HORIZONTAL SERIES OF ATTACHED UNITS WITH PROPERTY LINES SEPARATING THE UNITS.

(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH ~~(2)~~ PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, A SPRINKLER SYSTEM SHALL BE INSTALLED IN ACCORDANCE WITH ACCEPTED ENGINEERING PRACTICES THAT MEET STANDARDS THE STANDARD FOR THE INSTALLATION OF SPRINKLER SYSTEMS IN RESIDENTIAL OCCUPANCIES AS ADOPTED IN THE REGULATIONS OF THE STATE FIRE PREVENTION COMMISSION ~~OR THE LOCAL AUTHORITY HAVING JURISDICTION OVER THE ENFORCEMENT OF FIRE AND BUILDING CODES OR THE LOCAL AUTHORITY HAVING JURISDICTION OVER THE ENFORCEMENT OF FIRE AND BUILDING CODES~~ IN:

(I) EVERY NEWLY CONSTRUCTED DORMITORY FOR WHICH THE INITIAL BUILDING PERMIT IS ISSUED ON OR AFTER JULY 1, 1990;

(II) EVERY NEWLY CONSTRUCTED HOTEL FOR WHICH THE INITIAL BUILDING PERMIT IS ISSUED ON OR AFTER JULY 1, 1990;

(III) EVERY NEWLY CONSTRUCTED LODGING OR ROOMING HOUSE FOR WHICH THE INITIAL BUILDING PERMIT IS ISSUED ON OR AFTER JULY 1, 1990;

(IV) EVERY NEWLY CONSTRUCTED MULTIFAMILY RESIDENTIAL DWELLING FOR WHICH THE INITIAL BUILDING PERMIT IS ISSUED ON OR AFTER JULY 1, 1990; AND

(V) EVERY NEWLY CONSTRUCTED TOWNHOUSE FOR WHICH THE INITIAL BUILDING PERMIT IS ISSUED ON OR AFTER JULY 1, 1992.

(2) WITHIN A JURISDICTION IN WHICH BUILDING PERMITS ARE NOT ISSUED, A SPRINKLER SYSTEM REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE INSTALLED IN:

(I) EVERY DORMITORY, HOTEL, LODGING OR ROOMING HOUSE, OR MULTIFAMILY RESIDENTIAL DWELLING ON WHICH CONSTRUCTION BEGINS ON OR AFTER JULY 1, 1990; AND

(II) EVERY TOWNHOUSE ON WHICH CONSTRUCTION BEGINS ON OR AFTER JULY 1, 1992.
