#### 12-309. REINSTATEMENT OF EXPIRED LICENSES.

##### (A) EXPIRED FOR 4 YEARS OR LESS.

THE BOARD SHALL REINSTATE THE LICENSE OF AN INDIVIDUAL WHO HAS FAILED TO RENEW THE LICENSE FOR ANY REASON IF THE INDIVIDUAL:

(1) APPLIES TO THE BOARD FOR REINSTATEMENT WITHIN 4 YEARS AFTER THE LICENSE EXPIRES; AND

(2) MEETS THE RENEWAL REQUIREMENTS FOR THE APPROPRIATE LICENSE UNDER § 12-308 OF THIS SUBTITLE.

##### (B) EXPIRED FOR MORE THAN 4 YEARS.

THE BOARD MAY NOT REINSTATE A JOURNEY PLUMBER LICENSE, A MASTER PLUMBER LICENSE, OR A LIMITED LICENSE OF AN INDIVIDUAL WHO FOR ANY REASON FAILS TO APPLY FOR REINSTATEMENT WITHIN 4 YEARS AFTER THE LICENSE EXPIRED UNLESS THE INDIVIDUAL:

(1) MEETS THE RENEWAL REQUIREMENTS FOR THE APPROPRIATE LICENSE UNDER § 12-308 OF THIS SUBTITLE; AND

(2) PASSES THE APPROPRIATE EXAMINATION FOR OBTAINING A LICENSE UNDER THIS SUBTITLE.
