

EACH LICENSEE SHALL GIVE THE BOARD AND ANY APPROPRIATE LICENSING AUTHORITY WRITTEN NOTICE OF ANY CHANGE OF NAME, ADDRESS, OR EMPLOYMENT FROM THAT WHICH APPEARS ON THE CURRENT LICENSE, AT LEAST 10 WORKING DAYS BEFORE THE CHANGE IS TO TAKE EFFECT.

12-312. DENIALS, REPRIMANDS, SUSPENSIONS, AND REVOCATIONS -- GROUNDS.

SUBJECT TO THE HEARING PROVISIONS OF § 12-313 OF THIS SUBTITLE, THE BOARD MAY DENY A LICENSE TO ANY APPLICANT, REPRIMAND ANY LICENSEE, OR SUSPEND OR REVOKE A LICENSE IF THE APPLICANT OR LICENSEE:

- (1) FRAUDULENTLY OR DECEPTIVELY OBTAINS OR ATTEMPTS TO OBTAIN A LICENSE FOR THE APPLICANT OR LICENSEE OR FOR ANOTHER;
- (2) FRAUDULENTLY OR DECEPTIVELY USES A LICENSE;
- (3) IS GUILTY OF GROSS NEGLIGENCE, INCOMPETENCE, OR MISCONDUCT WHILE PROVIDING PLUMBING SERVICES OR ASSISTING IN PROVIDING PLUMBING SERVICES;
- (4) IS GUILTY OF VIOLATING THE STATE PLUMBING CODE OR APPLICABLE LOCAL PLUMBING CODE WHILE PROVIDING PLUMBING SERVICES OR ASSISTING IN PROVIDING PLUMBING SERVICES;
- (5) IS GUILTY OF AN UNFAIR OR DECEPTIVE TRADE PRACTICE, AS DEFINED IN § 13-301 OF THE COMMERCIAL LAW ARTICLE;
- (6) FAILS TO TRAIN AND CONTROL ADEQUATELY ANY PERSON WHO, WHILE UNDER THE DIRECTION AND CONTROL OF THE MASTER PLUMBER OR HOLDER OF A LIMITED MASTER PLUMBER LICENSE, SELLS OR GIVES ESTIMATES FOR PROVIDING PLUMBING SERVICES;
- (7) FAILS TO MAINTAIN THE LIABILITY INSURANCE REQUIRED UNDER § 12-501 OF THIS TITLE FOR A MASTER PLUMBER OR HOLDER OF A LIMITED MASTER PLUMBER LICENSE WHO CONTRACTS TO PROVIDE PLUMBING SERVICES ON BEHALF OF THE MASTER PLUMBER, HOLDER OF A LIMITED MASTER PLUMBER LICENSE, OR ANOTHER; OR
- (8) IS GUILTY OF VIOLATING § 12-605 OF THIS TITLE.
