A RESOLUTION TO ADOPT AN AMENDMENT TO THE CHARTER OF THE CITY OF NEW CARROLLTON, PRINCE GEORGE'S COUNTY, MARYLAND (SECTION 9 OF ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, EVERSTINE'S 1963 EDITION, AS AMENDED) AMENDING SUBSECTION (a), ENTITLED "TAX RATE," OF SECTION 12 OF SAID CHARTER, ENTITLED "TAXES AND ASSESSMENTS," TO SET FORTH FURTHER POWER AND AUTHORITY OF THE COUNCIL TO LEVY TAXES ON PERSONAL PROPERTY IN THE CITY.
