12-604. MISREPRESENTATION.

UNLESS AUTHORIZED UNDER THIS TITLE TO PROVIDE PLUMBING SERVICES, A PERSON MAY NOT REPRESENT TO THE PUBLIC, BY USE OF A TITLE, INCLUDING "MASTER PLUMBER", "REGISTERED PLUMBER", "LICENSED MASTER PLUMBER", "HOLDER OF LIMITED MASTER PLUMBER LICENSE", "LICENSED JOURNEY PLUMBER", "JOURNEY PLUMBER", OR "HOLDER OF A LIMITED JOURNEY PLUMBER LICENSE", BY DESCRIPTION OF SERVICES, METHODS, OR PROCEDURES, OR OTHERWISE, THAT THE PERSON IS AUTHORIZED TO PROVIDE PLUMBING SERVICES IN THE STATE.

12-605. INSTALLATION OF UNAPPROVED FIXTURES.

(A) IN GENERAL.

(1) A PERSON MAY NOT INSTALL A PLUMBING FIXTURE OR OTHER DEVICE THAT DOES NOT MEET THE STANDARDS FOR APPROVAL AS SET OUT IN THE STATE PLUMBING CODE OR ANY APPLICABLE LOCAL PLUMBING CODE.

(2) A PERSON MAY NOT SELL OR INSTALL A FIXTURE OR OTHER DEVICE THAT DOES NOT LIMIT WATER CONSUMPTION IN ACCORDANCE WITH THE STANDARDS ADOPTED BY THE BOARD.

(B) LOCAL ENFORCEMENT.

SUBJECT TO SUBSECTION (C) OF THIS SECTION, EACH LOCAL PLUMBING INSPECTOR SHALL ENFORCE THE PROHIBITION AGAINST THE INSTALLATION OF A PLUMBING FIXTURE THAT IS NOT WATER-CONSERVING UNDER THE STATE PLUMBING CODE OR ANY APPLICABLE LOCAL PLUMBING
