AN ACT to repeal and re-enact, with amendments, Section 267-4, Definitions, of Part 1, Standards, of Article I, General, of Chapter 267, Zoning, of the Harford County Code, as amended; to provide for new definitions for Road, Arterial; Road, Collector; and Road, Local in the Harford County Zoning Code; to provide that the Harford County Zoning Code be consistent with the Transportation Element of the Master Plan and the Harford County Road Code.

AN ACT to repeal Chapter 127, Fire Lanes; to repeal Subsection C and D of Section 244-4, Snow Emergencies, Subsection D and E of Section 244-5, Handicapped Parking, Section 244-8, Removal of Illegally Parked Vehicles, Section 244-9, Towing, Storage and Other Charges, and Section 244-10, Sale of Illegally Parked Vehicles of Chapter 244, Vehicles and Traffic, to renumber Sections 244-12, Handicapped Parking, 244-13, Authority of Council, 244-14, Authority of County Executive, 244-15, General Prohibition of Truck Traffic, 244-16, Signs, 244-17, Exception to Restrictions, 244-18, Restricted Routes Designated, 244-20, Parking in Residential Districts, and 244-21, Repair of Vehicles, to be Sections 244-5, 244-9, 244-10, 244-11, 244-12, 244-13, 244-14, 244-15, and 244-16 respectively of Chapter 244, Vehicles and Traffic; to repeal and re-enact, with amendments, Section 244-2, Traffic Control Devices; Violations and Penalties, Section 244-5, Impoundment and Sale of Vehicles Left Unattended of Chapter 244, Vehicles and Traffic; to add Section 244-6, Establishment, Removal of Obstruction, Cost of Signs or Markings, Section 244-7, Authority to Remove Obstructions, Charges, Section 244-8, Nonliability of County, Section 244-19, Citations and Penalties, Section 244-20, Parking Fines, and Section 244-21, Violations, to Chapter 244, Vehicles and Traffic; to add the definitions of Emergency Vehicle, Fire Company, Fire Lane, Fire Marshall, Officer, and Safe and Expeditious Manner to Section 244-1, Definitions, of Chapter 244, Vehicles and Traffic, all of the Harford County Code, as amended; to provide for the establishment and/or the increase of fines for parking violations.
