

(2) IN ADDITION TO THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION, IF CALIFORNIA ADOPTS ANY STATUTE, RULE, OR REGULATION THAT AFFECTS THE PROGRAM IN MARYLAND, THE PROVISIONS OF THIS SUBTITLE, ANY RULE OR REGULATION ADOPTED UNDER THIS SUBTITLE, AND ANY PROGRAM IMPLEMENTED UNDER THIS SUBTITLE SHALL TERMINATE WITHIN 1-YEAR 2 YEARS OF THE ENACTMENT OF THE STATUTE OR FINAL ADOPTION OF THE RULE OR REGULATION UNLESS THE GENERAL ASSEMBLY PASSES A JOINT RESOLUTION LEGISLATION IS ENACTED PRIOR TO THE EXPIRATION OF THE 1-YEAR 2-YEAR PERIOD EXPRESSING ITS APPROVAL OF ANY SUCH CHANGE AND ITS SUPPORT FOR THE CONTINUATION OF CONTINUING THE PROGRAM.

(A) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, THE ADMINISTRATION MAY NOT TITLE OR REGISTER UNDER TITLE 13 OF THE TRANSPORTATION ARTICLE ANY MOTOR VEHICLE THAT IS SUBJECT TO THE PROVISIONS OF THIS SUBTITLE IF THE MOTOR VEHICLE DOES NOT COMPLY WITH THE PROVISIONS OF THIS SUBTITLE OR ANY REGULATION ADOPTED UNDER THIS SUBTITLE.

(B) (1) THE ADMINISTRATION MAY, IN CONSULTATION WITH THE DEPARTMENT, ADOPT REGULATIONS TO EXEMPT CERTAIN MOTOR VEHICLES FROM THE PROGRAM.

(2) EXEMPTIONS ESTABLISHED UNDER PARAGRAPH (1) OF THIS SUBSECTION ~~ARE~~ SHALL BE LIMITED TO MOTOR VEHICLES WHICH WOULD BE EXEMPTED FROM THE LOW EMISSIONS VEHICLE PROGRAM.

(3) ANY MOTOR VEHICLE EXEMPTED UNDER THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION SHALL BE EXEMPT FROM THE REQUIREMENTS OF THIS SUBTITLE FOREVER AND THE ADMINISTRATION SHALL NOTE THE EXEMPTION ON THE TITLE OF THE MOTOR VEHICLE.

(C) THE ADMINISTRATION SHALL, IN CONSULTATION WITH THE DEPARTMENT, ADOPT REGULATIONS TO PROHIBIT THE TRANSFER OF MOTOR VEHICLES OR MOTOR VEHICLE ENGINES THAT ARE NOT IN COMPLIANCE WITH THE PROVISIONS OF THIS SUBTITLE, IF SUCH REGULATIONS ARE NECESSARY TO ACHIEVE EQUIVALENCE WITH THE REQUIREMENTS OF THE LOW EMISSIONS VEHICLE PROGRAM.

(A) A PERSON MAY NOT TRANSFER OR ATTEMPT TO TRANSFER A MOTOR VEHICLE OR MOTOR VEHICLE ENGINE THAT IS SUBJECT TO THE PROVISIONS OF THIS SUBTITLE ~~THAT~~ IF THE VEHICLE OR ENGINE DOES NOT COMPLY WITH THE PROGRAM.

(B) A PERSON MAY NOT PROCURE OR ATTEMPT TO PROCURE THROUGH FRAUD OR MISREPRESENTATION THE TITLE OR REGISTRATION OF A MOTOR VEHICLE THAT IS SUBJECT TO THE PROVISIONS OF THIS SUBTITLE ~~THAT~~ IF THE VEHICLE DOES NOT COMPLY WITH THE PROGRAM.
