Article 8 - Cecil County

The Board shall consist of eight (8) members, appointed by the Board of County Commissioners, of whom each Commissioner shall appoint two (2). One (1) member shall be appointed by the Board of Education. The Board of County Commissioners shall annually select, from its membership, an ex officio member for this Board, who shall serve without voting privileges.

All members of the Board, with the exception of the ex officio member, shall be appointed for [four (4) years] 3-YEAR STAGGERED TERMS from the first day of January of the year of their appointments or until their successors are appointed. Vacancies, except those at the expiration of a term, shall be filled in the same manner as the original appointments and for the unexpired term. All members of the Board shall serve without compensation, except that they may be reimbursed for necessary and proper expenses incurred while performing their duties thereon.
