(B) (1) THE COMMITTEE CONSISTS OF THE FOLLOWING ~~EIGHT~~ NINE MEMBERS:

(I) ~~TWO~~ THREE INSTITUTIONAL EDUCATORS WHOSE POSITIONS ARE INCLUDED IN THE INSTITUTIONAL EDUCATOR PAY PLAN ESTABLISHED UNDER § 6-303 OF THIS SUBTITLE TO BE APPOINTED BY THE GOVERNOR; AND

(II) ~~A REPRESENTATIVE OF THE SECRETARY OR A DESIGNEE OF THE SECRETARY FROM EACH OF THE FOLLOWING DEPARTMENTS:~~

1. THE DEPARTMENT OF EDUCATION, ~~DIVISION OF CORRECTIONAL EDUCATION~~;
2. THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES, ~~DIVISION OF CORRECTION~~;
3. THE DEPARTMENT OF JUVENILE SERVICES;
4. THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE;
5. THE DEPARTMENT OF PERSONNEL; AND
6. THE DEPARTMENT OF BUDGET AND FISCAL PLANNING.

(2) ~~(H)~~ THE STATE DIRECTOR OF THE CORRECTIONAL EDUCATION ASSOCIATION SHALL RECOMMEND TO THE GOVERNOR INDIVIDUALS TO SERVE AS THE INSTITUTIONAL EDUCATOR MEMBERS OF THE COMMITTEE. ~~EACH INSTITUTIONAL EDUCATOR MEMBER SHALL BE CHOSEN BY THE GOVERNOR~~ THE GOVERNOR SHALL TAKE THESE RECOMMENDATIONS INTO CONSIDERATION, BUT MAY APPOINT ANY INDIVIDUAL WHO IS AN INSTITUTIONAL EDUCATOR UNDER SUBSECTION (A) OF THIS SECTION, INCLUDING INSTITUTIONAL EDUCATORS EMPLOYED AT THE DEPARTMENT OF JUVENILE SERVICES AND THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE.

~~(H) EACH REMAINING MEMBER SHALL BE APPOINTED BY THE ADMINISTRATIVE HEAD OF THE DEPARTMENT THAT THE MEMBER REPRESENTS.~~

(C) EACH MEMBER OF THE COMMITTEE:

- (1) SHALL SERVE A 3-YEAR TERM; AND
- (2) (I) SHALL SERVE WITHOUT COMPENSATION; BUT

(II) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES IN ACCORDANCE WITH THE STANDARD STATE TRAVEL REGULATIONS.

(D) THE COMMITTEE SHALL DESIGNATE:

- (1) ONE MEMBER AS CHAIRMAN; AND
- (2) THE TIME AND PLACE OF ITS MEETINGS.
