(B) (1) ~~WITHIN 90 DAYS OF RECEIPT OF THE NOTICE REQUIRED IN SUBSECTION (A) OF THIS SECTION, A PERSON SUSPECTED OF ABUSE, NEGLECT, SELF-NEGLECT, OR EXPLOITATION MAY REQUEST IN WRITING THE DEPARTMENT OR A LOCAL DEPARTMENT TO AMEND OR EXPUNGE THE RECORD OR REPORT.~~
