- (7) (I) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBSECTION, IN MONTGOMERY COUNTY, A PERSON WHO HOLDS A CLASS B BEER, WINE AND LIQUOR LICENSE MAY BE ISSUED ONE ADDITIONAL CLASS B BEER, WINE AND LIQUOR LICENSE FOR USE IN A RESTAURANT IF THE RESTAURANT IS LOCATED WITHIN:
- 1. <u>CBD ZONED PROPERTY WITHIN THE ROCKVILLE TOWN</u> CENTER MIXED USE DISTRICT; OR
- 2. <u>AN ENCLOSED RETAIL MALL HAVING AT LEAST 700,000</u> SQUARE FEET OF GROSS FLOOR AREA.
- (II) THE MONTGOMERY COUNTY BOARD OF LICENSE COMMISSIONERS MAY NOT GRANT UNDER THIS PARAGRAPH MORE THAN:
- 1. TWO EXEMPTIONS FOR USE IN THE ROCKVILLE TOWN CENTER MIXED USE DISTRICT; AND
- <u>2. ONE EXEMPTION FOR USE IN EACH RETAIL MALL</u> DESCRIBED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH.
- (III) THE MONTGOMERY COUNTY BOARD OF LICENSE COMMISSIONERS MAY NOT GRANT UNDER THIS PARAGRAPH MORE THAN TWO EXEMPTIONS TO THE SAME PERSON OR FOR USE OF THE SAME PARTNERSHIP, CORPORATION, UNINCORPORATED ASSOCIATION, OR LIMITED LIABILITY COMPANY IN MONTGOMERY COUNTY, EXCEPT THAT A LICENSEE THAT HOLDS THE MAXIMUM NUMBER: OF LICENSES PERMITTED UNDER PARAGRAPHS (4) AND (6) OF THIS SUBSECTION MAY BE GRANTED ONLY ONE EXEMPTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 1993.

CHAPTER 326

(House Bill 709)

AN ACT concerning

Natural Resources Law Enforcement Officers - Appointment

FOR the purpose of extending indefinitely the authorization of the Secretary of Natural Resources to appoint certain Natural Resources law enforcement officers from a certain list of eligibles; providing a certain probationary period for Natural Resources law enforcement officers; repealing the termination date of Chapter 231 of the Acts of the General Assembly of 1991, as amended by Chapter 22 of the Acts of the General Assembly of 1992; correcting a cross-reference; and generally relating to the appointment and service of Natural Resources law enforcement officers.
