

(C) THE OFFICE OF THE ATTORNEY GENERAL MAY ACCEPT DONATIONS FROM INSURERS AUTHORIZED TO CONDUCT INSURANCE BUSINESS IN MARYLAND AND USE THESE FUNDS EXCLUSIVELY AS SPECIAL FUNDS TO OFFSET GENERAL FUND EXPENDITURES FOR THE INSURANCE FRAUD DIVISION.

(A) SUBJECT TO § 2-1312 OF THE STATE GOVERNMENT ARTICLE, ON OR BEFORE JANUARY 1 OF EACH YEAR, THE FRAUD DIVISION SHALL REPORT TO THE GOVERNOR AND THE GENERAL ASSEMBLY ON COMPLAINTS AND CASES FILED IN THE PREVIOUS FISCAL YEAR.

(B) THE REPORT SHALL INCLUDE THE NUMBER OF:

(1) COMPLAINTS RECEIVED RELATING TO INSURANCE FRAUD, CATEGORIZED ACCORDING TO INSURER, LINE OF INSURER, AND THE NATURE OF THE COMPLAINTS;

(2) COMPLAINTS REFERRED TO AND PROSECUTED BY A STATE'S ATTORNEY;

(3) COMPLAINTS PROSECUTED BY THE OFFICE OF THE ATTORNEY GENERAL;

(4) CALLS MADE TO THE INSURANCE FRAUD HOT LINE;

(5) COMPLAINTS RECEIVED FROM PERSONS REGULATED BY THE INSURANCE COMMISSIONER;

(6) THE NUMBER AND TYPE OF CONFIRMED ACTS OF INSURANCE FRAUD;

(7) CASES AND PERCENTAGE OF CASES RESULTING IN THE IMPOSITION OF A CIVIL OR CRIMINAL PENALTY; AND

(8) THE LEVEL OF COOPERATION AND COORDINATION BETWEEN THE OFFICE OF THE ATTORNEY GENERAL AND OTHER STATE AND FEDERAL AGENCIES IN THE ENFORCEMENT OF THIS SUBTITLE.

(A) THERE IS AN INSURANCE FRAUD ADVISORY COUNCIL.

(B) THE COUNCIL SHALL CONSIST OF NINE MEMBERS.

(C) (1) OF THE NINE MEMBERS:

(I) ONE SHALL BE A REPRESENTATIVE OF THE MARYLAND STATE POLICE;

(II) ONE SHALL BE A REPRESENTATIVE OF THE OFFICE OF THE ATTORNEY GENERAL;

(III) ONE SHALL BE A REPRESENTATIVE OF THE INSURANCE ADMINISTRATION;
