(S-2) "LOCAL LICENSING BOARD" MEANS A BOARD OF LICENSE COMMISSIONERS OF A COUNTY OR THE MAYOR AND ALDERMEN OF THE CITY OF ANNAPOLIS.

(g) (6) Except for a license transferred to a new location, a Class 6 pub-brewery license may be transferred under § 74 of this article if an application for transfer is filed with the [respective board of license commissioners or alcoholic beverages license issuing authority] LOCAL LICENSING BOARD and simultaneously filed with the State Comptroller's office.

(a) (1) A Class A beer license shall be issued by the [clerk of the circuit court] LICENSE ISSUING AUTHORITY of the county in which the place of business is located and shall authorize the holder thereof to keep for sale and sell beer at retail, in any quantity to any consumers at the place therein described, and to deliver the same in a sealed package or container, which package or container shall not be opened nor its contents consumed on the premises where sold.

(2) The annual fee for the license shall be \$25, UNLESS OTHERWISE PROVIDED IN THIS SECTION, and shall be payable to the [clerk] LOCAL COLLECTING AGENT before any license be issued, for distribution as hereinafter provided.

(a) (1) A Class B license shall be issued by the [clerk of the circuit court] LICENSE ISSUING AUTHORITY of the county in which the place of business is located, and shall authorize the holder thereof to keep for sale and sell beer at retail at any hotel or restaurant at the place therein described, for consumption on the premises or elsewhere.

(2) The annual fee for the license shall be \$50 [and], UNLESS OTHERWISE PROVIDED IN THIS SECTION, AND shall be payable to the [clerk,] LOCAL COLLECTING AGENT before any license is issued, for distribution as hereinafter provided.
