

(3) (i) A special-Class C (golf and country club) license may be issued [upon approval] by the Board of License Commissioners of Frederick County to any golf and country club in the county applying for the license which maintains at the time of the application for the license and continues to maintain a regular or championship golf course of nine holes or more. The license authorizes the licensee to keep for sale and to sell at retail any alcoholic beverages to members and guests at the licensed premises for on-sale consumption only. A country club may not sell alcoholic beverages for consumption off the premises or off the grounds of the club.

(k) (3) (I) In Prince George's County a special Class C (yacht club) license shall be issued[, upon the approval] by the Board of License Commissioners, UPON ITS APPROVAL OF THE APPLICATION, to any yacht club in said county applying therefor which has fifty (50) or more bona-fide members paying dues of not less than seventy-five dollars (\$75.00) per annum per member, which maintains at the time of application for the license a clubhouse with a seating capacity sufficient to accommodate at one time at least one hundred (100) persons, slips or berths for seventy-five (75) boats or more and at least five (5) acres of ground. Such a license shall authorize the holder thereof to keep for sale and to sell at retail any alcoholic beverages, to any member or guest when accompanied by a member at the place described in said license, for consumption on the licensed premises only and shall be subject to all the provisions of this article relating to beer, wine and liquor licenses, Class C, in force and effect in Prince George's County, except that restrictions on the sale of alcoholic beverages on Sunday found in § 103 of this article and elsewhere shall not apply; provided that in no event may alcoholic beverages be sold, served or consumed on the licensed premises on Sunday before twelve o'clock noon or after twelve o'clock midnight.

(II) The annual fee for such a license is \$1,300.

(III) The application for any such license filed on behalf of any such yacht club in Prince George's County shall be signed by at least one officer of said club, who shall be a resident, registered voter and taxpayer of Prince George's County.

(4) (i) 1. A special Class C (golf and country club) license shall be issued[, upon approval] by the Board of License Commissioners of Prince George's County, UPON ITS APPROVAL OF THE APPLICATION, to any golf and country club in said county applying therefor which has 200 or more bona fide members paying dues of not less than \$75 per annum per member, which maintains at the time of application for the license two or more tennis courts, a swimming pool at least 30 by 80 feet in size, and a regular or championship golf course of 9 holes or more, or has 500 or more bona fide dues-paying members and maintains at the time of the application for the license a regular or championship golf course of 18 holes or more. Such a license shall authorize the holder thereof to keep for sale and to sell at retail any alcoholic beverages, to any customer at the place described in said license, for consumption on or off its premises. The annual fee for said golf and country club licenses is \$1,500, which shall be paid to [said clerk] THE PRINCE GEORGE'S COUNTY DIRECTOR OF FINANCE before any such license is issued. The application for any of said licenses filed on behalf of any such golf and country club in Prince George's County shall be signed by at least one officer of said club, who shall be a resident, registered voter and taxpayer of Prince George's County. Such golf and country club license shall be subject to all the provisions of this article,
