

COUNTY LOCAL LAWS

Emergency Bill No. 1-92

AN ACT TO ADD NEW SECTION 10.2.18 TO PERMITTED PRINCIPAL USES AND STRUCTURES, UNDER SUB-SECTION A - INDUSTRIAL DISTRICT, SECTION 10, INDUSTRIAL DISTRICTS, OF ARTICLE V, DISTRICT REGULATIONS, OF THE KENT COUNTY ZONING ORDINANCE PERMITTING COMMERCIAL STABLES IN AN INDUSTRIAL DISTRICT, ESTABLISHING MINIMUM ACREAGE AND SETBACKS FROM PROPERTY LINES, SETBACKS FROM WATERS, STREAMS AND WETLANDS AND REQUIRING A WASTE MANAGEMENT PLAN.

AN ACT TO ADD NEW SECTION 6-10(d), 6-31(j), 6-31(k) AND 6-33(a)(5) REPEAL SECTION 6-21(d) AND REPEAL AND RE-ENACT WITH AMENDMENTS SECTIONS 6-7, 6-8, 6-9, 6-11(n), 6-11(t), 6-12, 6-13, 6-14(a), 6-15(a), 6-15(b)(1), (b)(2) AND (b)(3), 6-15(c), 6-17, 6-19, 6-20(d) AND (e), 6-21(c), 6-22, 6-23, 6-24, 6-30 PREAMBLE, 6-30(h), 6-30(i)(1), 6-30(j)(1), 6-30(k)(4), 6-32, 6-35, 6-38(22) AND (27), 6-40 OF ARTICLE III, CHAPTER 6, CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY (1984 EDITION, BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY", SUB-TITLE "LAND USE" PROVIDING FOR THE ISSUANCE OF A BUILDING PERMIT BEING CONTINGENT UPON APPROVAL OF A SEDIMENT CONTROL PLAN AND COMPLIANCE INSPECTIONS FOR APPROVED SEDIMENT CONTROL PLANS AND GENERALLY CORRECTING LANGUAGE IN THE ORDINANCE.

AN ACT TO ADD NEW ARTICLE IX TO CHAPTER 6 OF THE PUBLIC LOCAL LAWS OF KENT COUNTY (1984 EDITION, BEING ARTICLE 15 OF THE PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY" SUBTITLE "LAND USE", ENTITLED "STORMWATER MANAGEMENT ORDINANCE", TO FOLLOW IMMEDIATELY AFTER ARTICLE VIII THEREOF ESTABLISHING MINIMUM REQUIREMENTS AND PROCEDURES TO CONTROL THE ADVERSE IMPACTS ASSOCIATED WITH INCREASED STORMWATER RUNOFF.
