AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS - ARTICLE VII, CHAPTER 6, CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY (1984 EDITION, BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY", SUBTITLE "LAND USE", PROVIDING FOR A REVISED FLOOD PLAIN ORDINANCE WITH AMENDMENTS AS REQUIRED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY.

**Emergency Bill No. 5-92**

AN ACT TO ADD NEW SECTION 5-114 TO ARTICLE XI, CHAPTER 5, CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY (1984 EDITION, BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), TITLE "KENT COUNTY" SUB-TITLE "HEALTH AND SAFETY", TO FOLLOW IMMEDIATELY AFTER SECTION 5-113 THEREOF, TO PROVIDE FOR A MECHANICAL CODE WHICH WILL CONTROL THE INSTALLATION OF MECHANICAL SYSTEMS AND EQUIPMENT AND ESTABLISHING MINIMUM REQUIREMENTS FOR SAFE MECHANICAL SYSTEMS IN RESIDENTIAL BUILDINGS AND ALL OTHER BUILDINGS WHEREIN MECHANICAL SYSTEMS ARE TO BE INSTALLED.

**Emergency Bill No. 6-92**

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS SECTION 8-14 OF ARTICLE 1, CHAPTER 8 OF THE PUBLIC LOCAL LAWS OF KENT COUNTY, MARYLAND (1989 EDITION, BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND), TITLE "KENT COUNTY", SUB-TITLE "ROADS AND FENCES" PROVIDING FOR OBTAINING A PERMIT PRIOR TO PERFORMING ANY INSTALLATION OF NEW CONDUITS AND/OR CABLE FACILITIES WITHIN THE COUNTY RIGHTS OF WAY, OR MAINTENANCE AND REPAIRS TO ANY EXISTING FACILITIES WITHIN PAVED SECTIONS OF COUNTY ROADS AND INCREASING THE PENALTY FOR DAMAGE TO ROADS OR BRIDGES.
