SUBTITLE 2. SPECIAL PAY PROVISIONS.

6-201. SHIFT DIFFERENTIAL PAY.

- (A) IN GENERAL.
- (1) AN EMPLOYEE IS ENTITLED TO EXTRA PAY, KNOWN AS SHIFT DIFFERENTIAL PAY, IF THE EMPLOYEE:
- (I) IS EMPLOYED IN A POSITION DESIGNATED FOR THIS PURPOSE; AND
- (II) WORKS ON A FULL-TIME SHIFT OF AT LEAST 8 HOURS THAT STARTS ON OR AFTER 2:00 P.M. AND ON OR BEFORE 1:00 A.M.
- (2) A STATE-EMPLOYED FIRE FIGHTER IS ENTITLED TO SHIFT DIFFERENTIAL PAY FOR QUALIFYING HOURS IF THE FIRE FIGHTER WORKS ON A SHIFT OF AT LEAST 8 HOURS, REGARDLESS OF THE TIME THAT THE SHIFT STARTS.
 - (B) REGULATIONS:
- (1) THE SECRETARY SHALL ADOPT REGULATIONS FOR THE PAYMENT OF SHIFT DIFFERENTIAL PAY.
- (2) THE REGULATIONS ADOPTED UNDER THIS SECTION SHALL PROVIDE FOR FAIRNESS AND EQUITY AMONG ALL EMPLOYEES IN CONSIDERATION OF:
 - (I) THE HOURS WORKED;
 - (II) CONDITIONS AND PLACES OF EMPLOYMENT:
 - (III) PREVAILING PRACTICES IN THE LOCALITY; AND
- (IV) OTHER FACTORS THAT THE SECRETARY CONSIDERS RELEVANT UNDER THE CIRCUMSTANCES.

REVISOR'S NOTE: This section is new language derived without substantive change from former Art. 64A, § 27(d).
