ACCEPTANCE OF A CASH AWARD MADE UNDER THIS SUBTITLE CONSTITUTES AN AGREEMENT THAT USE BY THIS STATE OF ANY IDEA, METHOD, OR DEVICE FOR WHICH THE AWARD WAS GIVEN DOES NOT FORM THE BASIS OF ANY CLAIM AGAINST THIS STATE BY THE EMPLOYEE OR THE HEIRS OR ASSIGNS OF THE EMPLOYEE.

8-206. EFFECT OF DEATH OR SEPARATION.

8-207. EFFECT ON PROMOTION.
