

(8) TWO MEMBERS AT LARGE SELECTED BY THE COUNTY COMMISSIONERS EXECUTIVE COMMITTEE OF THE WASHINGTON COUNTY COUNCIL OF PTA'S. THE PRESIDENT OF THE COUNCIL MAY BE ONE OF THESE MEMBERS.

(C) (1) THE COUNTY COMMISSIONERS SHALL SOLICIT EACH ORGANIZATION LISTED IN SUBSECTION (B) OF THIS SECTION BEFORE ~~MAY~~ APRIL 1, 1996, AND BEFORE ~~MAY~~ APRIL 1 EACH FOURTH YEAR THEREAFTER, REQUESTING THAT THE ORGANIZATION RECOMMEND AN APPOINTEE TO THE COUNTY COMMISSIONERS BY ~~JUNE~~ MAY 15.

(2) THE COUNTY COMMISSIONERS SHALL APPOINT THE INDIVIDUAL RECOMMENDED BY EACH ORGANIZATION TO THE COMMISSION.

(3) THE COUNTY COMMISSIONERS SHALL PROVIDE PROFESSIONAL STAFF TO THE COMMISSION AS NECESSARY FOR THE COMMISSION TO ISSUE ITS REPORT.

(4) THE COUNTY COMMISSIONERS SHALL PROVIDE FUNDS NECESSARY FOR THE COMMISSION TO ADVERTISE ITS HEARINGS SO THAT THE PUBLIC WILL RECEIVE SUFFICIENT NOTICE AND AN OPPORTUNITY TO ATTEND AND PRESENT TESTIMONY AT THE HEARINGS.

~~(3)~~ (5) IF AN ORGANIZATION FAILS TO MAKE A RECOMMENDATION TO THE COUNTY COMMISSIONERS BY JUNE 1, THE COUNTY COMMISSIONERS SHALL APPOINT A MEMBERS WHO HAVE BEEN APPOINTED TO THE COMMISSION SHALL MEET, SOLICIT PROSPECTIVE MEMBERS FROM THE PUBLIC, AND SELECT BY MAJORITY VOTE A QUALIFIED SUBSTITUTE CITIZEN MEMBER TO THE COMMISSION TO SERVE THROUGH THE FOLLOWING DECEMBER 1.

(D) A MEMBER OF THE COMMISSION MAY NOT BE AN ELECTED OFFICIAL OR AN EMPLOYEE OF AN OFFICIAL WHOSE SALARY THE COMMISSION STUDIES.

(E) A MEMBER OF THE COMMISSION MAY NOT RECEIVE COMPENSATION BUT IS ENTITLED TO REIMBURSEMENT FOR EXPENSES AS AUTHORIZED BY THE COUNTY COMMISSIONERS.

(F) FROM AMONG ITS MEMBERS, THE COMMISSION SHALL ELECT A CHAIRMAN.

(G) (1) THE COMMISSION SHALL HOLD AT LEAST ONE PUBLIC HEARING EVERY 4 YEARS.

(2) THE COMMISSION SHALL PUBLISH NOTICE OF EACH HEARING IN A NEWSPAPER OF GENERAL CIRCULATION.

(A) THE COMMISSION SHALL MEET BEFORE JULY 1, 1996, AND BEFORE JULY 1 EVERY FOURTH YEAR THEREAFTER.

(B) FIVE MEMBERS OF THE COMMISSION ARE A QUORUM.
