- (7) (9) "SUBWHOLESALER'S LICENSE" MEANS-THE-SUBWHOLESALER LICENSE REQUIRED UNDER TITLE 16 OF THE BUSINESS REGULATION ARTICLE.
- (B) (1) A PERSON ENGAGED IN THE BUSINESS OF SELLING OR OTHERWISE DISTRIBUTING TOBACCO PRODUCTS FOR COMMERCIAL PURPOSES, INCLUDING PERSONS LICENSED UNDER TITLE 16 OF THE BUSINESS REGULATION ARTICLE, MAY NOT:
- (1) DISTRIBUTE ANY TOBACCO PRODUCT TO A MINOR, UNLESS THE MINOR IS ACTING SOLELY AS THE AGENT OF THE MINOR'S EMPLOYER, WHO IS IN THE BUSINESS OF DISTRIBUTING TOBACCO PRODUCTS;
 - (11) DISTRIBUTE CIGARETTE ROLLING PAPERS TO A MINOR; OR
- (3) DISTRIBUTE TO ANY MINOR A COUPON-REDEEMABLE FOR ANY TOBACCO PRODUCT; OR
- (3) DISTRIBUTE TO AN INDIVIDUAL IN A PUBLIC PLACE OR AT A PUBLIC EVENT ANY TOBACCO PRODUCT WITHOUT CHARGE OR AT A CHARGE LESS THAN THE BASIC COST, EXCEPT FOR SINGLE SERVINGS OF TOBACCO PRODUCTS IN TOBACCO SHOPS OR TRADE SHOWS TO INDIVIDUALS WHO ARE NOT MINORS;
- (4) <u>DISTRIBUTE TO AN INDIVIDUAL COUPONS REDEEMABLE FOR TOBACCO PRODUCTS; OR</u>
- (4) (5) DISTRIBUTE TO AN INDIVIDUAL TOBACCO PRODUCTS OTHER THAN IN THE ORIGINAL SEALED PACKAGE OR BOX THAT BEARS ALL HEALTH WARNINGS REQUIRED BY FEDERAL AND STATE LAW, EXCEPT FOR SINGLE SERVINGS OF TOBACCO PRODUCTS IN TOBACCO SHOPS OR TRADE SHOWS TO INDIVIDUALS WHO ARE NOT MINORS.
- (III) DISTRIBUTE TO ANY MINOR A COUPON REDEEMABLE FOR ANY TOBACCO PRODUCT.
- (2) <u>A PERSON NOT DESCRIBED UNDER PARAGRAPH (1) OF THIS SUBSECTION MAY NOT:</u>
 - (I) PURCHASE FOR OR SELL TO A MINOR ANY TOBACCO PRODUCT, OR
 - (II) DELIVER OR SELL TO A MINOR CIGARETTE ROLLING PAPERS.
- (C) THE PROVISIONS OF SUBSECTION (B) OF THIS SECTION DO NOT APPLY TO THE DISTRIBUTION OF A COUPON WHICH IS REDEEMABLE FOR ANY TOBACCO PRODUCT WHEN THE COUPON IS CONTAINED IN A NEWSPAPER, A MAGAZINE, OR ANY OTHER TYPE OF PUBLICATION IN WHICH THE COUPON IS INCIDENTAL TO THE PRIMARY PURPOSE OF THE PUBLICATION, OR SENT THROUGH THE MAIL.
- (D) IN A PROSECUTION FOR A VIOLATION OF SUBSECTION (B) (B) (I) OR (2) OF THIS SECTION, IT SHALL BE A DEFENSE THAT THE DISTRIBUTOR OF TOBACCO PRODUCTS, ROLLING PAPERS, OR COUPONS DEFENDANT EXAMINED THE PURCHASER'S OR RECIPIENT'S DRIVER'S LICENSE OR OTHER VALID
